概況

二零一一年第四季及二零一一年全年按開 支組成部分劃分的本地生產總值

初步數字顯示本地生產總值在二零一一年第四季較上年同期實質上升3.0%,這升幅與二零一二年二月一日發布按預先初步估計所得的升幅相同。二零一一年第三季的本地生產總值實質升幅爲4.3%。二零一一年全年與二零一零年比較,本地生產總值實質上升5.0%。

初步數字是採用最新的資料編製而成,是 二零一二年二月一日所發布的預先初步估計 的修訂數字。初步數字較二零一二年二月一日 發布的數字提供更詳盡的分項數據。

經季節性調整而作相連季度比較的本地 生產總值,在二零一一年第四季實質上升 0.4%。

按本地生產總值各個主要組成部分分析,私人消費開支在二零一一年第四季較上年同期實質上升7.1%,較第三季的9.8%增幅放緩。二零一一年全年與二零一零年比較,私人消費開支實質上升8.6%。

按國民經濟核算定義計算的政府消費開支,在二零一一年第四季較上年同期實質上升2.3%,而第三季的升幅爲1.3%。二零一一年全年與二零一零年比較,政府消費開支實質上升1.8%。

本地固定資本形成總額,在二零一一年第四季較上年同期實質上升8.8%,而第三季則實質上升11.2%。二零一一年全年與二零一零年比較,本地固定資本形成總額錄得7.2%的實質升幅。

本地固定資本形成總額中,機器、設備及電腦軟件開支在二零一一年第四季與上年同期比較實質上升20.5%,而第三季的升幅爲26.7%。

樓宇及建造開支在二零一一年第四季較上年同期實質上升4.9%,而第三季則上升1.7%。在這類別內,私營部門的樓宇及建造開支在二零一一年第四季實質微升1.0%,而公營部門的相應開支則錄得10.9%的增長。

General Observations

GDP by expenditure component for the fourth quarter of 2011 and the whole year of 2011

According to the preliminary figures, Gross Domestic Product (GDP) for the fourth quarter of 2011 increased by 3.0% in real terms over a year earlier. This growth rate was the same as that based on the advance preliminary figures released on 1 February 2012. The GDP real growth rate for the third quarter of 2011 was 4.3%. For 2011 as a whole, GDP increased by 5.0% in real terms over 2010.

The preliminary figures were compiled by incorporating the latest information available and were revised from the advance preliminary figures released on 1 February 2012. The preliminary figures provided more detailed breakdowns than those released on 1 February 2012.

On a seasonally adjusted quarter-to-quarter comparison basis, GDP increased by 0.4% in real terms in the fourth quarter of 2011.

Analysed by major GDP component, private consumption expenditure (PCE) increased by 7.1% in real terms in the fourth quarter of 2011 over a year earlier, moderating from the 9.8% growth in the third quarter. For 2011 as a whole, PCE increased by 8.6% in real terms over 2010.

Government consumption expenditure (GCE) measured in national accounts terms increased by 2.3% in real terms in the fourth quarter of 2011 over a year earlier, compared with the growth of 1.3% in the third quarter. For 2011 as a whole, GCE increased by 1.8% in real terms over 2010.

Gross domestic fixed capital formation (GDFCF) increased by 8.8% in real terms in the fourth quarter of 2011 over a year earlier, compared with the increase of 11.2% in the third quarter. For 2011 as a whole, GDFCF registered a growth of 7.2% in real terms over 2010.

Within the total GDFCF, expenditure on machinery, equipment and computer software increased by 20.5% in real terms in the fourth quarter of 2011 over a year earlier, compared with the 26.7% growth in the third quarter.

Expenditure on building and construction increased by 4.9% in real terms in the fourth quarter of 2011 over a year earlier, compared with the 1.7% increase in the third quarter. Within this category, expenditure on building and construction of the private sector increased marginally by 1.0% in real terms in the fourth quarter of 2011, while that of the public sector registered a growth of 10.9%.

同期,貨品出口總額(包括轉口及本地產品出口)實質上升2.0%,較二零一一年第三季的2.2%跌幅有所改善。貨品進口在二零一一年第四季與上年同期比較實質增長3.9%,而第三季則上升1.4%。二零一一年全年與二零一零年比較,貨品出口總額和貨品進口分別錄得3.6%和4.8%的實質升幅。

服務輸出在二零一一年第四季較上年同期實質上升4.0%,而第三季的升幅為5.1%。服務輸入在二零一一年第四季實質上升3.0%,而第三季的升幅則為1.5%。二零一一年全年與二零一零年比較,服務輸出和服務輸入分別實質上升6.3%和3.1%。

用作概括量度整體通脹的本地生產總值 內含平減物價指數,在二零一一年第四季較上 年同期上升3.4%,而第三季則上升4.7%。二零 一一年全年與二零一零年比較,本地生產總值 內含平減物價指數上升3.6%。

二零一一年第三季按經濟活動劃分的本地 生產總值

在二零一一年十二月下旬發布的二零一一年第三季以環比物量計算按經濟活動劃分的本地生產總值初步數字,在獲得更多資料後已作出修訂。

修訂數字顯示所有服務行業合計的淨產 值在二零一一年第三季實質上升3.9%,而第二 季的升幅為5.1%。

按組成行業分析及與一年前同期比較,進 出口貿易、批發及零售業的淨產值由二零一一 年第二季7.1%的實質升幅,放緩至第三季的 4.9%。主要是由於環球經濟環境轉差,令商品 貿易放緩所致。

金融及保險業的淨產值繼二零一一年第 二季較上年同期實質上升12.9%後,在第三季 上升8.5%。受集資活動及基金管理業務轉趨淡 靜所影響,該行業淨產值的升幅有所減慢。

地產、專業及商用服務業的淨產值,在二零一一年第三季與上年同期比較實質上升 0.9%,而第二季則上升1.3%。淨產值的增長稍 爲放緩是由於物業市場交投活動縮減所致。

住宿服務(包括酒店、賓館、旅舍及其他 提供短期住宿服務的機構單位)及膳食服務業 的淨產值繼二零一一年第二季較一年前同期 實質上升0.9%後,在第三季上升2.3%。 Over the same period, total exports of goods (comprising re-exports and domestic exports) increased by 2.0% in real terms, improving from the 2.2% decline in the third quarter. Imports of goods increased by 3.9% in real terms in the fourth quarter of 2011 over a year earlier, compared with the 1.4% increase in the third quarter. For 2011 as a whole, total exports and imports of goods recorded increases of 3.6% and 4.8% in real terms respectively over 2010.

Exports of services increased by 4.0% in real terms in the fourth quarter of 2011 over a year earlier, compared with the 5.1% increase in the third quarter. Imports of services increased by 3.0% in real terms in the fourth quarter of 2011, compared with the 1.5% increase in the third quarter. For 2011 as a whole, exports and imports of services increased by 6.3% and 3.1% in real terms respectively over 2010.

The implicit price deflator (IPD) of GDP, as a broad measure of overall inflation in the economy, increased by 3.4% in the fourth quarter of 2011 over a year earlier, compared with the 4.7% increase in the third quarter. For 2011 as a whole, the IPD of GDP increased by 3.6% over 2010.

GDP by economic activity for the third quarter of 2011

The preliminary figures of chain volume measures of GDP by economic activity for the third quarter of 2011, which were released in late December 2011, had been revised as more data became available.

The revised figures showed that net output in all the services activities taken together increased by 3.9% in real terms in the third quarter of 2011 from a year earlier, compared with the 5.1% growth in the second quarter.

Analysed by constituent sector and on a year-on-year comparison, net output in the import and export, wholesale and retail trades sector increased by 4.9% in real terms in the third quarter of 2011 from a year earlier, moderated from the 7.1% increase in the second quarter. This was mainly due to the moderation in merchandise trade amid the worsening global economic environment.

Net output in the financing and insurance sector grew by 8.5% in real terms in the third quarter of 2011 from a year earlier, following the 12.9% rise in the second quarter. The quieting down of fund raising activities and fund management business underpinned the slowdown in net output growth of this sector.

Net output in the real estate, professional and business services sector increased by 0.9% in real terms in the third quarter of 2011 from a year earlier, compared with the 1.3% increase in the second quarter. The slight drop in net output growth was attributable to the contracted trading activities in the property market.

Net output in the accommodation services (covered hotels, guesthouses, boarding houses and other establishments providing short term accommodation) and food services sector increased by 2.3% in real terms in the third quarter of 2011 from a year earlier, after the 0.9% rise in the second quarter.

運輸、倉庫、郵政及速遞服務業的淨產值,在二零一一年第三季較一年前同期實質上升6.0%,而第二季則上升4.5%。

資訊及通訊業的淨產值繼第二季上升 1.5%後,在二零一一年第三季較一年前同期實 質上升0.8%。

公共行政、社會及個人服務業的淨產值, 在二零一一年第三季較一年前同期實質上升 2.5%,與第二季2.4%的升幅相若。

就服務行業以外的其他行業而言,本地製造業的淨產值繼二零一一年第二季較一年前同期實質上升2.0%後,在第三季錄得0.2%的輕微升幅。

電力、燃氣和自來水供應及廢棄物管理業的淨產值在二零一一年第三季較一年前同期 實質上升1.3%,而第二季則上升3.2%。

建造業的淨產值在二零一一年第三季較一年前同期實質上升1.1%,而第二季則下跌 0.3%。

二零一零年按經濟活動劃分的本地生產總值(以當時價格計算)

以當時價格計算按經濟活動劃分的本地 生產總值統計數字,主要是根據按年經濟統計 調查所得的資料而編製,於分析不同經濟活動 對整體本地生產總值的貢獻十分有用。

二零一零年以當時價格計算按經濟活動 劃分的本地生產總值修訂數字顯示進出口貿 易、批發及零售業佔本地生產總值最大部分 (24.0%),其次是公共行政、社會及個人服務業 (16.8%)和金融及保險業(15.4%)。

二零一一年第三季的本地居民生產總值

二零一一年第三季本地居民生產總值數字,亦根據修訂後的本地生產總值作出相應修 訂。

在二零一一年第三季,以當時市價計算的本地居民生產總值較上年同期上升10.2%至4,964億元,而二零一一年第二季的升幅爲14.9%。

二零一一年第三季的本地居民生產總值 較本地生產總值多出61億元,顯示有相等數額 的對外要素收益淨流入,相當於該季本地生產 總值的1.2%。 Net output in the transportation, storage, postal and courier services sector increased by 6.0% in real terms in the third quarter of 2011 over a year earlier, compared with the 4.5% growth in the second quarter.

Net output in the information and communications sector grew by 0.8% in real terms in the third quarter of 2011 from a year earlier, following the 1.5% increase in the second quarter.

Net output in the public administration, social and personal services sector grew by 2.5% in real terms in the third quarter of 2011 over a year earlier, similar to the growth of 2.4% in the second quarter.

As for sectors other than the services sectors, net output in the local manufacturing sector recorded a slight increase of 0.2% in real terms in the third quarter of 2011 from a year earlier, after the 2.0% rise in the second quarter.

Net output in the electricity, gas and water supply, and waste management sector increased by 1.3% in real terms in the third quarter of 2011 from a year earlier, compared with the 3.2% increase in the second quarter.

Net output in the construction sector increased by 1.1% in real terms in the third quarter of 2011 from a year earlier, as against the 0.3% decrease in the second quarter.

GDP by economic activity at current prices for 2010

Statistics on GDP by economic activity at current prices, which are compiled mainly based on data collected from the annual economic surveys, are useful for analysis of the contribution of different economic activities to the total GDP.

The revised figures of GDP by economic activity at current prices for 2010 showed that the import and export, wholesale and retail trades sector accounted for the largest share (24.0%) of the GDP, followed by the public administration, social and personal services sector (16.8%), and the financing and insurance sector (15.4%).

GNP for the third quarter of 2011

The figures of Gross National Product (GNP) for the third quarter of 2011 were also revised accordingly based on the revised GDP estimates.

In the third quarter of 2011, the GNP increased by 10.2% over a year earlier to \$496.4 billion at current market prices, compared with the 14.9% increase in the second quarter of 2011.

Compared with GDP, the value of GNP was larger by \$6.1 billion in the third quarter of 2011, representing a net external factor income inflow of the same amount, and equivalent to 1.2% of GDP in that quarter.

扣除價格變動的影響後,二零一一年第三季的本地居民生產總值較上年同期實質上升5.3%。

二零一一年第三季的香港要素收益總流入爲2,447億元,相等於本地生產總值的49.9%,較上年同期上升8.8%。在要素收益總流入中,直接投資收益、有價證券投資收益及其他投資收益分別較上年同期上升8.3%、6.2%及37.7%。

二零一一年第三季的要素收益總流出較上年同期上升6.8%至2,387億元,相等於本地生產總值的48.7%。在要素收益總流出中,直接投資收益、有價證券投資收益及其他投資收益分別較上年同期上升4.1%、22.0%及33.6%。


把總流入和總流出一併計算,二零一一年 第三季的對外要素收益淨流入爲61億元,而二 零一一年第二季的收益淨流入爲243億元。 After netting out the effect of price changes, the GNP increased by 5.3% in real terms in the third quarter of 2011 over a year earlier.

Total factor income inflow into Hong Kong, estimated at \$244.7 billion in the third quarter of 2011 and equivalent to 49.9% of GDP in that quarter, increased by 8.8% over a year earlier. Within total factor income inflow, Direct Investment Income (DII), Portfolio Investment Income (PII) and Other Investment Income (OII) increased by 8.3%, 6.2% and 37.7% respectively over a year earlier.

Total factor income outflow, estimated at \$238.7 billion in the third quarter of 2011 and equivalent to 48.7% of GDP in the same period, increased by 6.8% over a year earlier. Within total factor income outflow, DII, PII and OII increased by 4.1%, 22.0% and 33.6% respectively over a year earlier.

Taking the inflow and outflow together, a net external factor income inflow of \$6.1 billion was recorded in the third quarter of 2011, compared with the net income inflow of \$24.3 billion in the second quarter of 2011.

本地生產總值的實質變動百分率 Percentage change in GDP in real terms




本地生產總值 二零一一年第四季 - 6 - Gross Domestic Product Fourth Quarter 2011



本地固定資本形成總額的實質變動百分率













本地生產總值 二零一一年第四季 - 8 - Gross Domestic Product Fourth Quarter 2011

註釋

本地生產總值的概念與編製方法

- 1. 本地生產總值是指一個國家或地區的所有常住生產單位,在一個指定的期間內,未扣除固定資本消耗的生產總價值。如果一個生產單位以一個國家或地區的經濟領域爲其經濟利益中心,這生產單位就是該國家或地區的常住單位。一個國家或地區的經濟領域,是指該國家或地區的政府所管治的地域,而在該領域內的人士、貨品及資本均可自由流動。
- 2. 於一九九七年七月一日,香港成爲中華人民 共和國的特別行政區。在本系列報告書中就一九 九七年七月或以後的統計資料而言,「香港」是 指香港特別行政區。香港特別行政區與中國內地 之間的經濟交易(例如貨品貿易及服務貿易), 視作國際交易。
- 3. 一個國家或地區的「按人口平均計算的本地 生產總值」是指把該國家或地區在某統計年的 「本地生產總值」除以該國家或地區在該年的人 口總數而得的數字。由二零零七年起的人口數字 已根據二零一一年人口普查於二零一二年二月 製備的結果所提供的最新基準性資料作出修 訂。由二零零七年至二零一一年的人均本地生產 總值數字已作出相應修訂。
- 4. 本地生產總值可以從不同方法計算。香港的 以當時價格及以物量計算的按年本地生產總值 數字分別以開支面和生產面編製。按季數字方 面,以物量計算的數字分別以開支面和生產面編 製,而以當時價格計算的本地生產總值則只以開 支面編製。
- 5. 進行有關經濟結構的分析較適宜使用以當時價格計算按經濟活動劃分的按年本地生產總值數列,而不是按季本地生產總值數列,因爲按季數據有時會大幅波動。統計先進的經濟體系的普遍做法都只是按年而不是按季公布以當時價格計算按經濟活動劃分的本地生產總值。

按開支組成部分劃分的本地生產總值

- 6. 以開支面編製的本地生產總值,是將貨品和服務的最終開支(包括私人消費開支、政府消費開支、本地固定資本形成總額、存貨增減以及貨品出口及服務輸出)的總和,減去貨品進口及服務輸入。各開支組成部分的詳細解說如下:
 - (i) 私人消費開支是住戶和爲住戶服務的私 人非牟利機構在貨品和服務方面的最終 消費開支價值。計算方法是把本地市場 內對貨品及服務的消費開支,加上本港 居民在境外的開支,減去非本地居民在 本地市場的開支。

Explanatory Notes

Concepts and Methods for Compiling GDP

- 1. GDP is a measure of the total value of production of all resident producing units of a country or territory in a specified period, before deducting allowance for consumption of fixed capital. A producing unit is considered as a resident in a country or territory if it maintains a centre of economic interest in the economic territory of that country or territory. The economic territory of a country or territory is the geographic territory administered by the government of the country or territory within which persons, goods and capital circulate freely.
- 2. On 1 July 1997, Hong Kong became a Special Administrative Region of the People's Republic of China. In respect of statistics in this series of report, "Hong Kong" stands for the Hong Kong Special Administrative Region with effect from July 1997. Data on transactions vis-à-vis the mainland of China (e.g. trade in goods and trade in services) are treated as international transactions.
- 3. Per capita GDP of a country or territory is obtained by dividing total GDP in a year by the population of that country or territory in the same year. Population figures since 2007 have been revised based on the results of the 2011 Population Census available in February 2012 as the up-to-date benchmark data. Per capita GDP figures from 2007 to 2011 have been revised accordingly.
- 4. GDP can be measured using different approaches. In Hong Kong, annual GDP at current prices and in volume terms are compiled using the expenditure approach and the production approach. For quarterly GDP, volume measures are compiled using both approaches while quarterly GDP at current prices is compiled using the expenditure approach only.
- 5. For analysis relating to economic structure, it is more appropriate to use *annual* rather than *quarterly* series of current price GDP by economic activity. This is because quarterly data are often subject to large fluctuations. It is a common practice of statistically advanced economies to publish current price GDP by economic activity on annual rather than quarterly basis.

GDP by expenditure component

- 6. Under the expenditure approach, GDP is compiled as total final expenditures on goods and services (including private consumption expenditure, government consumption expenditure, gross domestic fixed capital formation, changes in inventories and exports of goods and services), less imports of goods and services. Details of the expenditure components are described below:
 - (i) Private consumption expenditure refers to the value of final consumption expenditure on goods and services by households and private non-profit institutions serving households. It is calculated as the sum of consumption expenditure on goods and services in the domestic market and the expenditure of Hong Kong residents abroad, less the expenditure of non-residents in the domestic market.

- (ii) 政府消費開支是非參與商業活動的各個政府部門及非牟利半政府機構用於消費貨品及服務的開支。政府消費開支的計算方法,是將僱員報酬加上購買貨品及服務支出,扣除銷售貨品及服務的收入。參與商業活動的政府單位並不包括在內。這些政府單位和非參與商業活動政府部門的分別,在於前者生產的貨品和服務主要用作售予市民使用。
- (iii) 本地固定資本形成總額包括機器、設備 及電腦軟件的開支總額、樓宇及建造開 支和擁有權轉讓費用。這些數字是按公 營及私營部門分類列出,公營部門的數 字是指政府、半政府部門和公營機構的 資本開支。根據資產擁有權分類,出租 公屋的建築開支屬公營部門開支,至於 「居者有其屋計劃」則屬私營部門開 支。私營部門的樓宇及建造開支亦包括 地產發展商從新建樓宇工程所得的毛 利。
- (iv) 存貨增減是指商業機構 (主要是製造商 及分銷商)所持有的半製成品、原料及 製成品存貨的實質增減價值。
- (v) *貨品出口及進口*:貨品出口包括以離岸價計算的本地產品出口和貨品轉口。貨品進口亦是以離岸價格計算。對外貿易中的非貨幣黃金亦包括在內。
- (vi) 服務輸出及輸入包括本港居民與世界各地進行的服務交易。主要服務組別包括運輸服務、旅遊服務、商貿服務及其他與貿易相關的服務,以及其他服務。而其他服務包括多類服務例如金融服務、保險服務、商業及專業服務。

按經濟活動劃分的本地生產總值

- 7. 從生產面編製的本地生產總值,是本地各生產單位(例如工廠、商店及服務機構)的「增加價值」的總和。一個生產單位的「增加價值」是其生產的貨品和服務的價值(即「生產總額」)減去在其生產過程中耗用的貨品和服務的價值(即「中間投產消耗」)。要獲得以市價計算的本地生產總值,必須將產品稅加進有關經濟活動以基本價格計算的增加價值總額。
- 8. 以基本價格計算的增加價值的定義,是以基本價格計算的生產總額減去以購買者價格計算的中間投產消耗。基本價格是生產者生產一個單位的貨品或服務,在扣除任何產品稅但包括產品補貼後所收取的價值。以基本價格計算的增加價值更能反映生產者實際支付及收取的價格。

- (ii) Government consumption expenditure refers to the expenditure on consumption goods and services by government departments which are not engaged in market activities and quasi-government non-profit institutions. It is calculated as the sum of compensation of employees and purchases of goods and services, less receipts from sales of goods and services. Government units engaged in market activities are not covered. They are distinguished from other government departments in that they are engaged in the production of goods and services mainly for sale to the public.
- (iii) Gross domestic fixed capital formation covers the gross value of expenditure on machinery, equipment and computer software; expenditure on building and construction; and costs of ownership transfer. Statistics are classified by public and private sectors. Public sector includes capital expenditure of government, quasi-government institutions and public corporations. According to the ownership criterion for classifying fixed assets into public and private sectors, construction expenditure on public rental housing is classified to the public sector whereas that on Home Ownership Scheme is classified to the private sector. Private sector expenditure on building and construction also includes real estate developers' margin of new building projects.
- (iv) Changes in inventories refer to the value of physical change in the inventories of work-in-progress, raw materials and finished goods held by business enterprises, mainly manufacturers and distributors.
- (v) Exports and imports of goods: Exports of goods include domestic exports and re-exports of goods recorded on f.o.b. basis. Imports of goods are also valued on f.o.b. basis. External trade of non-monetary gold is also included.
- (vi) Exports and imports of services cover transactions in services between Hong Kong residents and the rest of the world. The major service groups include transportation services, travel services, merchanting and other trade-related services, and other services. Other services cover a wide variety of services including financial services; insurance services; business and professional services.

GDP by economic activity

- 7. Under the production approach, GDP is the sum of the value added of resident producing units, e.g. factories, shops and service organisations. Value added of a producing unit is the value of goods and services it produces (i.e. "gross output") less the value of goods and services it uses up in the course of production (i.e. "intermediate consumption"). To arrive at GDP measured at market prices, it is necessary to add taxes on products to the sum of value added of various economic activities measured at basic prices.
- 8. Value added at basic prices is defined as output at basic prices less intermediate consumption valued at purchasers' prices. Basic price is the amount receivable by the producer for a unit of good or service provided which excludes any taxes on products, but includes subsidies on products. Value added at basic prices can better reflect the prices actually paid and received by the producers.

- 9. 按經濟活動劃分的本地生產總值提供數據,以助對各行業進行各方面的分析。首先,以當時價格計算按經濟活動劃分的按年本地生產總值,可以用來分析各類經濟活動較長期趨勢的相對重要性,有助展示經濟根本結構的變化。所應用的數據,是各經濟活動的按年增加價值在以基本價格計算的本地生產總值內所佔的百分比。第二,以物量計算按經濟活動劃分的本地生產總值的按年變動百分率可提供數據,幫助評估不同經濟活動的相對表現。第三,以物量計算按經濟活動劃分的本地生產總值可以用來分析各類經濟活動對整體經濟增長的貢獻,有助了解經濟增長的來源。
- 10. 生產面本地生產總值採用《香港標準行業分類2.0版》的經濟活動分類方法。為編製國民經濟核算,還需包括一項名為樓字業權的經濟活動。
- 11. 在國民經濟核算方面,樓宇業權被視爲一項經濟活動,涵蓋:(一)自住業主(即居住在自己擁有的住宅的住戶)爲本身提供的租賃服務;(二)業主使用政府及私人非牟利機構的自置及自用樓宇;及(三)業主以個人身分向租客提供的租賃服務。

以環比物量計算的本地生產總值

- 12. 以物量計算的本地生產總值,是採用按年重訂權數及環比連接法編製而成的。根據這編製方法,每一年度本地生產總值的物量計算是採用前一年的價格結構作爲權數來涵總各組成部分的物量估計而成。在編製某一年度的物量估計時,,首先是根據前一年的價格重新計算各個主要組成部分的物量,編製的方法是將各個組成部分中的最細分項目,採用相關的價格指數平減以當時價格計算的數值。該年的本地生產總值的物量估計是接前一年價格計算的各個主要組成部分的物量估計經總而得。
- 13. 然後,每年的本地生產總值短期物量指數是把該年本地生產總值的物量估計除以前一年以當時價格計算的本地生產總值而得。由於價格變動的因素已被撤除,短期物量指數便可反映本地生產總值的實質增長。本地生產總值及其組成部分的短期物量指數均量度按年實質變動。將各年份按前一年權數計算的短期物量指數以環比的方式連接到所選定的參照年,便可得出本地生產總值及各組成部分的環比物量指數的連續時間序列。
- 14. 以環比物量計算的本地生產總值的基年(即編製總體物量估計時所採用的價格結構和權數的年份),原則上是前一年。就統計方法而言,這與以固定價格計算的本地生產總值數列作每年更

- 9. GDP by economic activity provides data to support sectoral analyses from various perspectives. Firstly, annual current price GDP by economic activity provides data for analysing the longer-term trend in the relative importance of different economic activities. This helps depict changes in the underlying economic structure. The statistics used are the percentage share of annual current price value added of various economic activities to overall GDP at basic prices. Secondly, the year-on-year percentage change of volume measures of GDP by economic activity provides data for assessing the relative performance of different economic activities. Thirdly, volume measures of GDP by economic activity provides data for analysing the contribution of economic activities to overall economic growth. This facilitates analysis of the source of growth of an economy.
- 10. The Hong Kong Standard Industrial Classification Version 2.0 (HSIC V2.0) is used in classifying economic activities of GDP under production approach. For national accounting purposes, an additional activity namely ownership of premises is also covered.
- 11. Ownership of premises is treated as an economic activity in the national accounts. This activity covers: (a) the leasing services provided by residential owner-occupiers (i.e. households living in dwellings that they own) to themselves; (b) owners using owner-occupied premises of government and private non-profit institutions; and (c) the leasing services provided to tenants by owners of premises in individual capacity.

Chain Volume Measures of GDP

- 12. In compiling the volume measures of GDP, the annually re-weighted chain linking approach is adopted. Under this calculation method, the volume measure of GDP for each year is compiled by aggregating the volume estimates of its components using the price structures in the preceding year as weights. For a particular year, the volume estimates of major components revalued at preceding year prices are first produced by "deflating" the current price values of sub-components by the relevant price indices at the most disaggregated levels. The volume estimate of GDP is then obtained by aggregating the volume estimates of GDP components revalued at preceding year prices.
- 13. The short-term volume index of GDP for each year is then calculated by dividing the volume estimate of GDP for that year by the current price GDP for the preceding year. With the effect of price changes eliminated, the short-term volume index reflects the real growth of GDP. The short-term volume indices for GDP and its components measure year-to-year movements in volume terms. To obtain a continuous time series of the chain volume indices of GDP and its components, the preceding-year weighted short-term volume indices for various years are chain linked to a selected reference year.
- 14. For the chain volume measures of GDP, the base year which refers to the year from which the price structures are used as weights for deriving the aggregate volume measures, is always the preceding year in principle. Statistically speaking, it has the same effect of rebasing the constant price GDP series

按開支組成部分劃分的本地生產總值

- 16. 編製以物量計算按開支組成部分劃分的本地生產總值時,會採用一個標準的平減物價方法。每個開支組成部分物量數值的計算方法,是把經平減物價的各個分項組成部分加起來;而這些分項組成部分物量數值的編製,是採用適當的物價指數平減以當時價格計算的數值,或是根據基年的價格而將現時數量重新計算而得。把以物量計算的各個開支組成部分進一步相加起來,便取得以物量計算的本地生產總值。
- 17. 本地生產總值內含平減物價指數(或簡稱本地生產總值平減物價指數)通常會用作概括地量度一個經濟體系的整體通貨膨脹。這個指數涵蓋有關消費、投資和進出口的價格變動。
- 18. 將以當時價格計算的本地生產總值,除以以環比物量計算的本地生產總值,便可以隱含方式計算出本地生產總值平減物價指數。使用類似方法,將每個以當時價格計算的本地生產總值組成部分,除以相應的環比物量數值,便可以隱含方式計算出個別開支組成部分的相關內含平減物價指數。因此,本地生產總值及其開支組成部分的內含平減物價指數,並不是用以計算有關的物量數值的。

按經濟活動劃分的本地生產總值

19. 隨着政府統計處近年擴大和加強按月及按季經濟統計調查,更多經濟數據得以齊備,包括短期經濟指標(例如服務業的按季業務收益)和爲某些選定服務業編製的生產者價格指數。生產者價格指數旨在量度本地生產者對其產品及服務所收取價格的平均變動。生產者價格是指本地

every year. The chain volume measures of GDP take account of the up-to-date price structures as weights in aggregating the volume estimates of the GDP components, thus providing a better measure of the real growth rate of an economy.

15. The chain volume index series can be converted into the chained dollar series by multiplying the chain volume index for each year by the current price value in the reference year. In other words, the chained dollar series are derived by extrapolation of the current price value in the reference year backward and forward using the chain volume index as the Thus, real growth rates of GDP (and its components) calculated from the chained dollar estimates are the same as those calculated from the corresponding chain volume indices. As the extrapolation process is carried out for an aggregate and its components independently in calculating the chained dollar series, the sum of the extrapolated values of the components do not, in general, equal exactly to the extrapolated value of an aggregate. It should be noted that non-additivity arises from purely mathematical reasons; the discrepancy should not be interpreted as an indication of the data quality of GDP statistics.

GDP by expenditure component

- 16. In compiling the GDP by expenditure component in volume terms, a standard deflation approach is adopted. The volume measure of each expenditure component is obtained by adding up the respective deflated sub-components, each of the latter is compiled either by deflating the current price value using an appropriate price index, or by revaluing the current period quantities at base year prices. The volume measures of the expenditure components are further aggregated to arrive at the volume measures of GDP.
- 17. The implicit price deflator of GDP (or GDP deflator in short) is generally used as a broad measure of overall inflation in the economy. It takes account of all price changes relating to consumption, investment, exports and imports.
- 18. The GDP deflator is implicitly obtained by dividing the current price GDP by the chained dollar estimate of GDP. Similarly, by dividing each of the GDP components at current prices with each of the corresponding chained dollar figures, the respective implicit price deflators for individual expenditure components are implicitly obtained. Hence as it stands, the implicit price deflators of GDP and its expenditure components are not used as inputs for compiling the corresponding volume measures.

GDP by economic activity

19. With the development and enhancement of monthly and quarterly economic surveys conducted by the Census and Statistics Department in recent years, more economic data are available, including the availability of short-term economic indicators (e.g. quarterly business receipts of service industries) and producer price indices (PPIs) for selected services industries. PPI is a measure of the average change in prices of

編製本地生產總值的資料來源

- 21. 編製按開支組成部分劃分的本地生產總值 的資料來源,包括對外貿易統計、對工商機構及 住戶的按年、按季及按月統計調查、政府帳目、 以及各政府部門和其他組織的行政資料。
- 22. 至於按經濟活動劃分的按年本地生產總值,資料來源主要是根據涵蓋所有主要經濟活動的「經濟活動按年統計調查」以及行政紀錄所得的資料。編製以物量估計按經濟活動劃分的按季本地生產總值的資料來源,主要包括對工商機構及住戶的按季及按月統計調查、政府帳目、以及各政府部門和其他組織的行政資料。

本地生產總值的發表形式

- 23. 在發表以物量計算按經濟活動劃分的按季本地生產總值後,以開支面編製的本地生產總值 仍會繼續用作爲單一本地生產總值數字。以開支 面編製的本地生產總值已編製了一段頗長時間, 並提供準確和及時的經濟實質增長量度。
- 24. 統計差額是以當時價格計算,以開支面編製的本地生產總值與以生產面編製的本地生產總值之間的差額。這差額是由於使用不同資料來源及估算方法而引起的。

本地生產總值數字發布的名稱法

25. 香港某一期間的本地生產總值,首次公布的數字稱爲「初步數字」。當獲得更多資料後,這些數字會作出修訂。這例行修訂符合國際一貫的做法,即盡早採用部分資料來編製和發表本地生產總值數字。其後經修訂的數字稱爲「修訂數字」。

goods and services received by local producers. Producer prices are transacted prices, net of any discounts, rebates or allowances given to buyers but including surcharges received by producers. The availability of such data enables the compilation of quarterly volume measures of GDP by economic activity.

20. Volume estimates of value added of economic activities in Hong Kong is generally compiled using four methods: (a) single extrapolation of base year value added by deflated gross output measures (e.g. business receipts deflated by PPI); (b) single extrapolation of base year value added by volume / quantity measures such as volume of trade and physical units of outputs; (c) single extrapolation of base year value added by input indicators such as hours worked; (d) double indicators methods. The first two methods are most frequently applied in Hong Kong for compiling quarterly volume estimates of value added, as in statistically advanced economies (e.g. Australia, New Zealand and U.K.). For detailed method and indicators used, please refer to Section 4 of the report 2011 Gross Domestic Product published in February 2012.

Data Sources for Compiling GDP

- 21. The data sources used for compiling GDP by expenditure component include external trade statistics, annual, quarterly and monthly surveys on industrial/business establishments and on households, government accounts and administrative data from government departments and other organisations.
- 22. As for GDP by economic activity, data sources for compiling annual figures mainly cover data collected from Annual Survey of Economic Activities which cover all major economic activities, and administrative records. The data sources for compiling quarterly volume estimates mainly include quarterly and monthly surveys on industrial/business establishments and on households, government accounts and administrative data from government departments and other organisations.

Presentation of GDP

- 23. With the introduction of the quarterly volume measures of GDP by economic activity, the practice of using GDP compiled from the expenditure approach as the single measure of GDP is to continue. GDP compiled from the expenditure approach has been produced for a long time, providing a timely and accurate measure of economic growth in real terms.
- 24. Statistical discrepancy refers to the difference in values of current price GDP compiled using the expenditure and production approaches, as a result of the adoption of different data sources and estimation methods.

Nomenclature for Data Release of GDP

25. In Hong Kong, the first release of GDP in respect of a period is called "Preliminary figures". When more data become available, the preliminary figures will be revised. This routine revision is in accordance with international practice to compile and release GDP figures at the earliest possible time by using only partial data. All those figures published subsequently, on

本地生產總值的修訂及公布辦法

- 26. 從開支面編製的按年本地生產總值初步數字,是在統計年度結束後約兩個月公布。至於從生產面編製的按年本地生產總值初步數字,由於資料所限,只能在該統計年度結束後約十一個月發表。隨後,已發表的本地生產總值開支面及生產面的按年數字便會根據最新資料作出修訂。每年的最終數字會在該統計年度結束後第三年的二月份公布。
- 27. 按開支組成部分劃分的按季本地生產總值 初步數字,在統計季度結束後兩個月內公布。這 些按季數列其後會根據最新資料,尤其是在納入 按年數據的時候,作出修訂。本地生產總值的按 季數字是刊載在《本地生產總值》季刊內。
- 28. 以物量計算按經濟活動劃分的本地生產總值的按季數列,會在統計季度結束後略少於三個月以新聞稿形式公布。編製按經濟活動劃分的本地生產總值的時滯,比編製按開支組成部分劃分的本地生產總值的較長,這是因爲編製以物量計算按經濟活動劃分的按季本地生產總值所需的資料,大部分是從以機構爲統計調查單位的各類統計調查得來,這些機構通常需要較多時間填報資料給政府統計處。
- 29. 本刊物內二零一零年及以後的數列,在得到 更多資料時會作出修訂。
- 30. 根據本地生產總值的首次估算和在三年後公布而已納入所有定期資料來源所得的數字的差異,過去五年期間按季本地生產總值實質增長率的「平均修訂」⁽¹⁾是0.1個百分點。同期的「平均絕對修訂」⁽¹⁾則少於0.5個百分點。「平均修訂」及「平均絕對修訂」分別量度修訂的方向和幅度,有助評估首次公布數字的可信性。

revision, are called "Revised figures". The figures are finalised when data from all regular sources are incorporated. For the first release of GDP in respect of the fourth quarter of 2011 and the whole year of 2011 in the 2011 Gross Domestic Product, they are called "Advance preliminary figures" which were released three weeks earlier than the normal release of "Preliminary figures". This earlier schedule was adopted as the timetable of the 2012-13 Budget has been advanced. The figures presented in this report are the preliminary figures for the fourth quarter of 2011 and the whole year of 2011. These preliminary figures are revised figures of the advance preliminary figures.

Revision and Publication Schedule of GDP

- 26. For annual GDP compiled by expenditure approach, preliminary figures are released about two months after the reference year. For annual GDP compiled by production approach, preliminary figures are released about eleven months after the reference year because of data limitation. Subsequently, both sets of annual GDP figures are revised based on latest information available until they become finalised around the third February after the reference year.
- 27. Preliminary figures for quarterly GDP by expenditure component are released less than two months after the reference quarter. The quarterly series are then revised and released based on latest information available, in particular when the annual data are incorporated. Quarterly GDP statistics are published in the quarterly report on *Gross Domestic Product*.
- 28. The quarterly series of volume measures of GDP by economic activity is released with a time lag of slightly less than three months after the reference quarter in a press release. The time lag for producing GDP by economic activity is longer than that of GDP by expenditure component. This is because the volume measures of quarterly GDP by economic activity are mainly compiled from various surveys on firms, for which more time is normally required for the companies to report data to the Census and Statistics Department.
- 29. In this report, GDP series for the year 2010 and onwards are subject to further revision as more data become available.
- 30. Based on the differences between the first estimate of the GDP and the figure released three years later which has incorporated data from all regular sources, the "average revision" of the real growth rates of quarterly GDP over a period of five years is 0.1% point. The "average absolute revision" over the same period is less than 0.5% point. The "average revision" and "average absolute revision" measure the direction and size of revisions respectively and are useful for assessing the reliability of the first release figures.

本地生產總值按季數字應用時須注意的要 點

31. 本地生產總值按季數列,提供最新資料,用 作評估當時的經濟表現。但在應用這些資料時, 應該留意,由於數據所限,本地生產總值及其組 成部分的按季數列,有時會作出重大修訂。普遍 來說,本地生產總值按季數列的準確程度,是較 其按年數列爲低。

經季節性調整的本地生產總值

- 32. 本地生產總值按季數字是會受季節性變動影響。例如第三季及第四季的本地生產總值,通常會高於同年的第一季及第二季。因此,在比較相連兩季的價值時,必須十分小心。不過,如計算按年同季的增長率,即是把某一季的數字與上一年同季比較,則大致上可剔除這些季節效應。
- 33. 本地生產總值及其一些開支組成部分(包括私人消費開支、政府消費開支、貨品出口、服務輸出、貨品進口和服務輸入)的經季節性調整數列,現時已有編製。然而,由於本地資本形成總額並沒有明顯的季節性模式,所以並沒有就這個組成部分編製經季節性調整的數列。
- 34. 經季節性調整的數列,由於季節性效應就統計方法而言已予剔除,所以相連兩個季度的數字可以進行更有意義的比較。將本地生產總值原來數列的按年變動數字與經季節性調整數列的相連季度變動數字一起進行分析,能更清楚看到本地生產總值的趨勢,尤其是在經濟出現轉折點的時候。
- 35. 自二零零八年第四季開始,編製經季節性調整的本地生產總值及其組成部分的方法由過往「X-11自迴歸一求和一移動平均」(X-11 ARIMA)方法更改爲「X-12自迴歸一求和一移動平均」(X-12 ARIMA)方法。自二零零六年第一季開始的經季節性調整的數字亦已按這個新方法作出修訂。「X-12自迴歸一求和一移動平均」方法改良自「X-11自迴歸一求和一移動平均」方法,能提供更佳的模型建造及模型評估能力。

各組成部分在本地生產總值的按年實質變 動百分率中所佔的比率

36. 各組成部分在本地生產總值實質變動中所佔的比率,是量度個別組成部分的變動對本地生產總值變動的影響。計算個別組成部分i在某季t的本地生產總值的按年實質變動百分率中所佔的比率的方法,是把該組成部分i在某季t的按年實質變動百分率乘以該組成部分i在前一年相同季度對本地生產總值的物量所佔比重而得的。

Caution on the Use of Quarterly GDP Figures

31. Quarterly GDP provides up-to-date information for assessing the current economic performance. However, users should note that quarterly series of GDP and its components are sometimes subject to large revision because of data limitations. Generally speaking, the quarterly series are less precise than the annual series.

Seasonally Adjusted GDP

- 32. Quarterly GDP figures are subject to seasonal variations. For instance, the value of the GDP are normally higher in the third and fourth quarters than in the first and second quarters of the same year. Therefore, great care has to be exercised in comparing the value of a quarterly GDP with that for the preceding quarter. Such seasonal effects, nevertheless, may be largely removed by calculating the year-on-year growth rate, which compares a quarterly figure with the corresponding one in the preceding year.
- 33. Seasonally adjusted data series are currently compiled for the aggregate GDP and some of its expenditure components, including private consumption expenditure, government consumption expenditure, exports of goods, exports of services, imports of goods and imports of services. However, seasonally adjusted data series is not compiled for gross domestic capital formation, as no clear seasonal pattern can be identified in this component.
- 34. In the seasonally adjusted series, seasonal effects have been removed statistically, thus enabling meaningful quarter-to-quarter comparison. When the year-on-year changes in the original GDP series and the quarter-to-quarter changes in the seasonally adjusted GDP series are analysed together, the trend of the GDP can be more clearly discerned, particularly in regard to turning points in the economy.
- 35. Starting from the fourth quarter of 2008, seasonal adjustments of GDP and its components are performed using the X-12 ARIMA method to replace the previous X-11 ARIMA method. The seasonally adjusted figures since the first quarter of 2006 have also been revised using the new method. The X-12 ARIMA method is an update to the X-11 ARIMA method with enhanced modelling and diagnostic capabilities.

Component Contributions to Year-on-year Rate of Change in Real Terms of GDP

36. The contributions to the percentage change in real terms of GDP provide a measure of the composition of GDP rate of change that is attributable to changes in individual components. The percentage point contribution of component i to the year-on-year percentage change of GDP in a particular quarter t is compiled by multiplying the year-on-year percentage change of component i in quarter t by the volume share of component i in GDP in the same quarter of previous year.

本地居民生產總值的概念與編製方法

- 37. 本地居民生產總值是指一個國家或地區的居民,由從事各項經濟活動而賺取的總收益,不論該等經濟活動是否在該國家或地區的經濟領域內進行。換言之,編製本地居民生產總值應包括本地居民在經濟領域內或領域外從事各類經濟活動的收益,而扣除非本地居民在經濟領域內從事經濟活動的收益。
- 38. 計算本地居民生產總值,可用以下方程式:

本地居民生產總值 = 本地生產總值

- + 本地居民從經濟領域 外所賺取的要素收益
- 非本地居民從經濟領域內所賺取的要素收益
- 39. 一個國家或地區的「按人口平均計算的本地居民生產總值」是指把該國家或地區在某統計年的「本地居民生產總值」除以該國家或地區在該年的人口總數而得的數字。由二零零七年起的人口數字已根據二零一一年人口普查於二零一二年二月製備的結果所提供的最新基準性資料作出修訂。由二零零七年至二零一零年的人均本地居民生產總值數字已作出相應修訂。
- 40. 某一年度以環比物量計算的本地居民生產總值 是將該年的環比物量指數乘以參照年的當時價格數 值而得的。本地居民生產總值的環比物量指數的連續 時間序列是採用按年重訂權數及環比連接法編製而 成。
- 41. 於一九九七年七月一日,香港成爲中華人民 共和國的特別行政區。香港特別行政區與中國內 地之間的經濟交易、資產與負債數據,分別視作 對外交易及對外頭寸。因此,香港與內地之間的 要素收益流動,視作對外要素收益流動,並計算 在香港的本地居民生產總值之內。
- 42. 對外要素收益流動的分類,基本上類似國際貨幣基金在一九九三年公布的《國際收支平衡手冊》內收入帳目的標準組成部分。這些收益組成部分稱爲直接投資收益、有價證券投資收益、其他投資收益及僱員報酬。
 - (i) *直接投資收益*是指本地居民在經濟領域 以外從直接投資所賺取的收益及非本地 居民在經濟領域以內從直接投資所賺取 的收益,而直接投資者對該業務擁有持 久利益及在管理經營決定上具有相當程 度的影響力或控制權。在統計上,若投 資者持有一間公司10%或以上的表決 權,便被視爲能長期有效地影響有關公

Concepts and Methods for Compiling GNP

- 37. GNP is a measure of the total income earned by residents of a country or territory from engaging in various economic activities, irrespective of whether the economic activities are carried out within the economic territory or outside. In other words, in compiling GNP, earnings of residents from various economic activities within or outside the economic territory are included, whereas earnings of non-residents from economic activities within the economic territory are excluded.
- 38. GNP is compiled by the following formula:

GNP = GDP

- + Factor income earned by residents from outside the economic territory
- Factor income earned by non-residents from within the economic territory
- 39. Per capita GNP of a country or territory is obtained by dividing GNP in a year by the population of that country or territory in the same year. Population figures since 2007 have been revised based on the results of the 2011 Population Census available in February 2012 as the up-to-date benchmark data. Per capita GNP figures from 2007 to 2010 have been revised accordingly.
- 40. The chained dollar estimate of GNP for a particular year is obtained by multiplying the chain volume index for that year by the current price value in the reference year. In compiling the continuous time series of the chain volume indices of GNP, the annually re-weighted chain linking approach is adopted.
- 41. On 1 July 1997, Hong Kong became a Special Administrative Region of the People's Republic of China. Data on transactions, and assets and liabilities vis-à-vis the mainland of China (the Mainland) are treated as external transactions and external positions respectively. Hence, factor income flows between Hong Kong and the Mainland are treated as external factor income flows and are covered in Hong Kong's GNP figures.
- 42. The classification of EFIF is basically similar to the classification of standard components of the Income Account of the *Balance of Payments Manual (BPM)* published by the International Monetary Fund in 1993. These income components are direct investment income (DII), portfolio investment income (PII), other investment income (OII) and compensation of employees (CE).
 - (i) Direct Investment Income refers to earnings of residents from their direct investment outside the economic territory and earnings of non-residents from their direct investment within the economic territory, in which direct investors have a lasting interest and a significant degree of influence or an effective voice in the management. For statistical purpose, an effective voice is taken as equivalent to a holding of 10% or more of the voting power of a company. These earnings are in the form of

本地居民生產總值的資料來源

43. 本地居民生產總值是根據本地生產總值及「對外申索、負債及收益統計調查」所得的對外要素收益流動數據編製,並輔以由其他來源所得資料。這項統計調查是根據《普查及統計條例》進行。

實質本地總收入、實質本地居民總收入和本 地居民可支配總收入

44. 以前一年價格計算的實質本地總收入是將本地生產總值加上貿易價格比率變動的調整計算而得。這指標所量度的實質本地總收入,能反映實質生產額的對外購買力。由於進出口價格的相對變動,引致以一定數量的出口產品所能換取

receipts of distributed dividends, share of undistributed profits, net interest receipts from inter-company debts and gross rentals. External investment in real estate, as specified by *BPM*, is also a form of direct investment. By statistical convention, land and other immovable structures and objects (e.g. building) in a country or territory can only be owned by residents of that country or territory. If a Hong Kong resident owns real estate outside the economic territory of Hong Kong, he should be regarded as owning a nominal company in the country or territory in question which in turn owns the real estate. The relationship between such nominal company and legal owner of the land and structures is then treated as a direct investment relationship.

- (ii) Portfolio Investment Income refers to earnings of residents from investment in non-resident equity securities (e.g. stocks and shares) and debt securities (e.g. bonds and notes, money market instruments), and earnings of non-residents from investment in resident equity securities and debt securities. Different from investors making direct investment, portfolio investors in such equity securities and debt securities have no lasting interest or influence in the management of the companies they invest. A holding of less than 10% of the voting power of a company is regarded as portfolio investment.
- (iii) Other Investment Income refers to interest inflow from, and outflow to, non-residents arising from other financial claims and liabilities that are not classified as DII or PII. Examples of these claims and liabilities include non-marketable loans, currency and deposits, trade credits and financial leases. Interest income receivable and payable are net of the financial intermediation services.
- (iv) Compensation of Employees refers to labour income earned by non-residents from their employment within the economic territory of Hong Kong and labour income earned by residents from their employment outside the economic territory. It comprises wages, salaries and other remuneration whether paid in cash or in kind.

Data Sources for Compiling GNP

43. GNP is compiled based on GDP and data on EFIF collected from the Survey of External Claims, Liabilities and Income (SECLI), supplemented by data from other sources. The survey is conducted under the provision of the Census and Statistics Ordinance.

Real Gross Domestic Income, Real Gross National Income and Gross National Disposable Income

44. Real Gross Domestic Income (RGDI) at preceding year prices is calculated as the GDP plus terms of trade adjustment. It reflects the external purchasing power of the real output, as the relative movements in import and export prices result in a varying volume of imports being exchangeable for a given

volume of exports. The terms of trade adjustment is calculated as ($\frac{X}{Pm} - \frac{X}{Px}$), where X is the total value of exports of goods

and services at current prices, Pm the price index for imports of goods and services and Px the price index for exports of goods and services. The chain volume measure of RGDI is calculated using the annually re-weighted chain linking approach.

- 45. Real Gross National Income (RGNI) at preceding year prices is obtained by adding to RGDI the real net EFIF. It measures the real purchasing power of the total income earned by residents of a country or territory. The chain volume measure of RGNI is calculated using the annually re-weighted chain linking approach.
- 46. Gross National Disposable Income is derived as the GNP plus net current transfers. It measures the income available to residents for final consumption and gross saving.
