

1. 概念及方法

- 1.1 消費物價指數量度住戶一般所購買的消費 商品及服務的價格水平隨時間而變動的情況。消 費物價指數的按年變動率,是廣泛被用作反映消 費者所面對的通貨膨脹的指標。
- 1.2 由於不同開支範圍的住戶的開支模式各有差別,消費物價轉變對它們的影響也各有不同。因此,香港編製三項針對不同開支組別住戶的消費物價指數。甲類、乙類及丙類消費物價指數分別根據較低、中等及較高開支範圍的住戶的開支模式編製而成。綜合消費物價指數根據以上所有住戶的整體開支模式編製,反映消費物價轉變對整體住戶的影響。

- 1.3 每月的消費物價指數是根據(一)有關住戶的開支模式及(二)統計月內搜集的價格資料編製。
- 1.4 以二零零四至零五年為基期的消費物價指數所採用的開支權數是以政府統計處在二零零四年十月至二零零五年九月間進行的住戶開支統計調查所得的住戶開支模式為根據。本報告內的所有統計表及分析,均根據以二零零四至零五年為基期的消費物價指數數列。

1. Concepts and methods

- 1.1 The Consumer Price Index (CPI) measures the changes over time in the price level of consumer commodities and services generally purchased by households. The year-on-year rate of change in the CPI is widely used as an indicator of the inflation affecting consumers.
- 1.2 As households in different expenditure ranges have varying expenditure patterns, the impacts of consumer price changes on households in different expenditure ranges are different. Hence, three series of CPIs, each referring to households in a different expenditure range, are compiled in Hong Kong. The CPI(A), CPI(B) and CPI(C) are compiled based on the expenditure patterns of households in the relatively low, medium and relatively high expenditure ranges respectively. A Composite CPI is compiled based on the overall expenditure pattern of all the above households taken together to reflect the impact of consumer price changes on the household sector as a whole.
- 1.3 Monthly CPIs are compiled on the basis of (a) expenditure patterns of relevant households and (b) prices collected in the reference month.
- 1.4 The expenditure weights for compiling the 2004/05-based CPI series are derived based on the household expenditure patterns obtained from the Household Expenditure Survey (HES) conducted during October 2004 to September 2005 by the Census and Statistics Department. All tables and analyses in this report are based on the 2004/05-based CPI series.

1.5 以二零零四至零五年爲基期的各項消費物價指數數列的開支範圍及所佔住戶的百分比臚列如下:

- 1.6 上述的開支範圍是以二零零四年十月至二零零五年九月基期內的物價計算。將自基期起物價轉變的影響計算在內,調整至二零一零年的價格水平,甲類、乙類及丙類消費物價指數所涵蓋住戶的每月平均開支,分別大約在4,400元至17,300元之間、17,300元至31,100元之間及31,100元至67,900元之間,而綜合消費物價指數所涵蓋住戶的每月平均開支則大約在4,400元至67,900元之間。
- 1.7 在物價變動資料方面,政府統計處持續地進行一項按月零售物價統計調查,藉此搜集住戶消費籃子內各項商品及服務的價格變動資料。政府統計處每月在本港各區大約四千間零售商店(例如超級市場、街市檔位、百貨公司及時裝店)及服務行業商號(例如電影院、醫院及美容院)搜集約共四萬五千個價目。搜集價格資料的方式,主要是採用外勤訪問形式進行,亦有部分以電話查詢或郵遞問卷方式進行。
- 1.8 至於一些主要服務如公共交通、電力及郵遞服務的價格數據,則直接從有關機構搜集或從行政記錄中獲得。而私人房屋租金方面,有關新訂租約、續訂租約及現時租戶的租金資料,是透過一項以私人房屋租戶爲對象的按月抽樣統計調查搜集得來。另一方面,有關公營房屋租金變動的數據則由香港房屋委員會及香港房屋協會定期提供。

1.5 The expenditure brackets for and percentages of households covered in the various 2004/05-based CPI series are as follows:

- 1.6 The above expenditure ranges relate to prices in the base period from October 2004 to September 2005. Taking into account the impact of price changes since the base period, the monthly household expenditure ranges of the CPI(A), CPI(B), and CPI(C) adjusted to the price level of 2010 are broadly equivalent to \$4,400-\$17,300, \$17,300-\$31,100 and \$31,100-\$67,900 respectively, and that of the Composite CPI is broadly equivalent to \$4,400-\$67,900.
- 1.7 As regards information on price changes, the C&SD continuously conducts a Monthly Retail Price Survey to capture the price changes of items included in the household consumption basket. The C&SD collects some 45 000 price quotations each month from around 4 000 retail outlets (e.g. supermarkets, market stalls, department stores and fashion shops) and service providers (e.g. cinemas, hospitals and beauty salons) throughout the territory. Price data are collected mainly by field visits and some also through the modes of telephone or postal enquiries.
- 1.8 As for principal services such as public transport, electricity and postal services, price data are either collected directly from the companies concerned or obtained from administrative records. Rental data on private housing for new, renewed and continued lettings are collected from a monthly sample survey on private housing renter households. On the other hand, data on rental movements of public housing are regularly provided by the Hong Kong Housing Authority and the Hong Kong Housing Society.

1.9 根據定義,某一個月份的消費物價指數,是通過比較在該月份與在基期購買同一籃子的消費項目所需付的總開支而計算出來的。在數學上,這等同於運用已更新至一年前(或一個月前)的價格水平的開支比重,把每個消費項目在當月所錄得的按年(或按月)價格變動加權,然後計算總和。換句話說,用以編製消費物價指數的計算公式已充分計及因個別項目自基期以來的價格變動而直接引致的開支權數變動。因此,這些變動不會影響消費物價指數及其變動率的準確性。相關的技術細節詳載於《二零零四至零五年住戶開支統計調查及重訂消費物價指數基期》的附錄二。

- 1.10 按二零零四至零五年度價格水平計算的二零一零年十二月消費物價指數內各商品/服務類別的開支權數,以及更新至一年前(即二零零九年十二月)及一個月前(即二零一零年十一月)的價格水平的開支權數列於本報告第五十三至五十四頁的附錄,以供參考。
- 1.11 值得留意是住戶的消費模式會因應其收入 及其它社會經濟因素的變動而改變。因此,除上 述的價格因素外,開支比重亦會受這些影響而隨 時間逐漸轉變。例如,住戶一般傾向多買一些價 格升幅較小的商品和服務,以替代價格升幅較大 的商品和服務。由於這種替代效應,根據固定消 費模式計算的消費物價指數,可能會高估了價格 的升幅。然而,過去的經驗顯示,消費模式只會 隨時間慢慢地轉變,而在少於五年間的累積變化 一般都不會對消費物價指數的變動率構成顯著影 響。因此,香港消費物價指數的開支權數會每隔 五年更新一次。這做法符合國際統計標準。新一 輪重訂消費物價指數的開支權數已於二零零九年 十月展開。

- By definition, the CPI in a specific month is computed by comparing the total expenditure required to purchase a basket of consumption items in that month with that required to purchase the same basket in the base period. Mathematically, this is equivalent to computing the composite sum of the year-on-year (or month-to-month) price changes of individual items in that month, each weighted by the corresponding item-specific expenditure weight updated to the price level in a year (or month) ago. In other words, the CPI compilation formula has already taken into account changes in expenditure weights directly caused by price changes in individual items since the base period and thus, the accuracy of the CPI and its rate of changes are not affected by such changes. Relevant technical details are fully discussed in Appendix 2 of the report 2004/05 Household Expenditure Survey and the Rebasing of the Consumer Price Indices.
- 1.10 The expenditure weights of individual commodity/service sections in the CPI in December 2010 based on the price level in 2004/05, as well as those updated to the price levels in the same month of the preceding year (i.e. December 2009) and in the preceding month (i.e. November 2010), are shown in <u>Appendix</u> on pages 53-54 of this report for reference.
- It should be noted that in addition to the price factor mentioned above, the expenditure weights do change gradually over time due to changes in consumption pattern of households in response to such factors as changes in income and other socio-economic factors. For example, households usually tend to buy more of the goods and services with smaller price increases to substitute those with larger price increases; and due to such substitution effect, the CPI compiled based on fixed consumption pattern tends to over-state price increases over time. However, experience revealed that changes in consumption pattern would only take place gradually and generally changes accumulated in a period of less than five years would not have a significant impact on the rate of change in the CPI. Therefore, the expenditure weights of the CPI are updated once every five years in Hong Kong. The practice conforms to international statistical A new round of updating for the expenditure weights of the CPI has been launched in October 2009.

- 1.12 一併研究消費物價指數原來數列的按年變動數字和經季節性調整數列的按月變動數字,有助分析消費物價的最新趨勢。經季節性調整數列的按月變動仍會受其他不規則的因素影響而波動。參考經季節性調整的指數在最近三個月內的平均每月變動率,能更清楚看到消費物價指數的趨勢。
- 1.13 由於經季節性調整的數列已透過統計方法 剔除季節性變異,可更有意義地比較相連月份數 字。

2. 摘要統計數字

2.1 消費物價指數及其變動率的最新數字列載 於下頁的表甲。消費物價指數自二零零七年起的 變動率受到數項政府一次性紓困措施所影響,包 括房屋委員會及房屋協會豁免二零零七年二月份 公營房屋租金、二零零七年四至九月和二零零八 年一月至二零零九年三月寬減每季最高值5,000元 的差餉、房屋協會豁免二零零八年二月份公營房 屋租金、政府代繳二零零八年八至十月份、二零 零九年八至九月份及二零一零年七至八月公營房 屋租金、自二零零八年八月起豁免僱員再培訓徵 款、由二零零八年九月起,政府每月爲每個電力 住宅用戶戶口注入300元電費補貼,最多提供3,600 元的累積補貼、二零零九年四月至二零一一年三 月寬減每季最高值1,500元的差餉、以及房屋委員 會豁免二零一零年九月公營房屋租金。剔除所有 這些政府一次性紓困措施的影響後的變動率亦列 載於表甲。

- 1.12 For analysing the latest trend in consumer prices, it is useful to study the year-on-year changes in the original CPI series and the month-to-month changes in the seasonally adjusted series together. The month-to-month changes in the seasonally adjusted series still tend to fluctuate due to other irregular factors. The trend of the CPIs may be more clearly discerned by looking at the average monthly rates of change of the seasonally adjusted indices during the latest three months.
- 1.13 In the seasonally adjusted series, seasonal variations have been eliminated by statistical methods, thus enabling figures for consecutive months to be compared more meaningfully.

2. Summary statistics

The latest available figures for the CPIs and their rates of change are summarized in Table A on The rates of change in CPIs since the next page. 2007 were affected by a number of Government's one-off relief measures, including the waiver of public housing rentals by Housing Authority and Housing Society for the month of February 2007; the rates concession of up to \$5,000 per quarter in April to September 2007 and January 2008 to March 2009; the waiver of public housing rentals by Housing Society for the month of February 2008; Government's payment of public housing rentals in August to October 2008, August to September 2009 and July to August 2010; the suspension of Employees Retraining Levy since August 2008; Government's monthly electricity charge subsidy of \$300 to each residential electricity account starting from September 2008, subject to a maximum cumulative amount of \$3,600; the rates concession of up to \$1,500 per quarter in April 2009 to March 2011; and the public housing rental waiver by Housing Authority in September 2010. The rates of change upon removing the effects of all these Government's one-off relief measures are also shown in Table A.

The rates of change in CPIs since 2007 were affected by a number of Government's one-off relief measures, including the public housing rental waiver by Housing Authority and Housing Society in February 2007; the rates concession of up to \$5,000 per quarter in April - September 2007 and January 2008 - March 2009; the public housing rental waiver by Housing Society in February 2008; Government's payment of public housing rentals in August - October 2008, August - September 2009 and July - August 2010; the suspension of Employees Retraining Levy since August 2008; Government's provision of electricity charge subsidy starting from September 2008; the rates concession of up to \$1,500 per quarter in April 2009 - March 2011; and the public housing rental waiver by Housing Authority in September 2010. The figures in brackets denote the rates of change upon removing the effects of all these Government's one-off relief measures.

3. 消費物價指數與上年同月比較的變動 詳情


- 3.1 在二零一零年十二月份,綜合、甲類、乙類及丙類消費物價指數均錄得按年升幅,分別爲3.1%、3.5%、3.0%及2.7%。如下頁的<u>表乙</u>所示,剔除所有政府一次性紓困措施的影響,綜合、甲類、乙類及丙類消費物價指數的按年升幅分別爲2.8%、3.0%、2.7%及2.7%。
- 3.2 爲了更清楚地觀察到通脹的趨勢,剔除所有政府一次性紓困措施的影響後的綜合消費物價指數的按年變動率顯示於下面<u>圖1</u>。

3. Detailed changes in the CPIs, as compared with same month in preceding year

- 3.1 In December 2010, the Composite CPI, CPI(A), CPI(B) and CPI(C) all registered year-on-year rates of increase, at 3.1%, 3.5%, 3.0% and 2.7% respectively. As shown in <u>Table B</u> on the next page, netting out the effects of all Government's one-off relief measures, the year-on-year rates of increase in the Composite CPI, CPI(A), CPI(B) and CPI(C) were 2.8%, 3.0%, 2.7% and 2.7% respectively.
- 3.2 The year-on-year rates of change in the Composite CPI after netting out the effects of all Government's one-off relief measures are presented graphically in <u>Chart 1</u> below for discerning the inflationary trend more clearly.

3.4 二零一零年十二月份與二零零九年十二月份比較,指數錄得升幅的類別有電力、燃氣及水(在綜合消費物價指數中爲13.0%及在甲類消費物價指數中爲17.3%,主要是由於部份住戶已用完政府所提供的一次性電費補貼);食品(不包括外出用膳)(6.4%及6.4%);衣履(3.4%及0.9%);交通(3.0%及1.7%);外出用膳(2.8%及2.7%);雜項物品(2.8%及2.4%);住屋(2.5%及3.0%);雜項服務(1.9%及1.8%)和煙酒(0.7%及0.6%)。

- 3.5 另一方面,耐用物品指數在二零一零年十二月份錄得按年跌幅(在綜合消費物價指數中為-2.9%及在甲類消費物價指數中為-2.2%)。
- 3.6 消費物價指數中各商品/服務類別指數及其按年變動率的時間數列分別列載於表1(甲)至1(丁)及表2(甲)至2(丁)。而各商品/服務組別指數的按年變動情況則在表3(甲)至3(丁)列出。至於各類別指數在消費物價指數整體變動中所佔的比率則列載於表5。
- 3.7 消費物價總指數和各類別指數的變動情況 及其按年變動率顯示於圖2及3。

- 3.4 Compared with December 2009, increases in the section indices in December 2010 were recorded for electricity, gas and water (13.0% in the Composite CPI and 17.3% in the CPI(A), mainly because some households had used up the full amount of Government's one-off electricity charge subsidy); food (excluding meals bought away from home) (6.4% and 6.4%); clothing and footwear (3.4% and 0.9%); transport (3.0% and 1.7%); meals bought away from home (2.8% and 2.7%); miscellaneous goods (2.8% and 2.4%); housing (2.5% and 3.0%); miscellaneous services (1.9% and 1.8%) and alcoholic drinks and tobacco (0.7% and 0.6%).
- 3.5 On the other hand, year-on-year decrease was recorded in December 2010 for index for durable goods (-2.9% in the Composite CPI and -2.2% in the CPI(A)).
- 3.6 The time series of the CPIs and their year-on-year rates of change at commodity/service section level are presented respectively in <u>Tables 1(A) to 1(D)</u> and <u>Tables 2(A) to 2(D)</u>. The year-on-year movements at commodity/service group level are given in <u>Tables 3(A) to 3(D)</u>. The contributions of each section to the overall changes in CPIs are shown in <u>Table 5</u>.
- 3.7 Movements of the all-item CPIs and their section indices together with their year-on-year rates of change are presented graphically in <u>Charts</u> 2 and 3.

4. 消費物價指數與上月比較的變動詳情

- 4.2 二零一零年十二月份各商品/服務類別指數及其按月變動率臚列於下頁的表丁。
- 4.3 各商品/服務類別指數中,雜項服務指數在綜合、甲類、乙類及丙類消費物價指數中分別上升1.2%、0.6%、1.4%及1.3%。而電力、燃氣及水指數的相應升幅為1.0%、0.5%、2.0%及0.4%。另一方面,衣履指數分別下跌2.4%、1.7%、2.2%及3.2%。其他類別指數的變動則比較輕微。

- 4.4 以下簡要地解釋各商品/服務類別指數在 二零一零年十一月與十二月間的變動。
- 4.5 <u>食品</u>指數在綜合、甲類、乙類及丙類消費物價指數中分別上升0.8%、0.8%、0.9%及0.9%,主要是由於外出用膳費用上升。

4. Detailed changes in the CPIs, as compared with preceding month

- 4.1 Compared with November 2010, the Composite CPI, CPI(A), CPI(B) and CPI(C) increased by 0.5%, 0.5%, 0.6% and 0.5% respectively in December. Netting out the effects of all Government's one-off relief measures, the month-to-month rates of change in the Composite CPI, CPI(A), CPI(B) and CPI(C) were 0.5%, 0.5%, 0.6% and 0.5% respectively. This was mainly because the charges for package tours, private housing rentals and the costs for meals bought away from home increased.
- 4.2 The indices and month-to-month rates of change of the CPIs for December 2010, analysed by section of commodity/service, are shown in <u>Table D</u> on the next page.
- indices for 4.3 Among the various commodity/service sections, the index miscellaneous services increased by 1.2%, 0.6%, 1.4% and 1.3% in the Composite CPI, CPI(A), and CPI(C) respectively. corresponding increases in the index for electricity, gas and water were 1.0%, 0.5%, 2.0% and 0.4%. On the other hand, the index for clothing and footwear decreased by 2.4%, 1.7%, 2.2% and 3.2% respectively. Movements in the indices for other sections were relatively small.
- 4.4 The following explains briefly the movement of the index for each commodity/service section between November and December 2010.
- 4.5 The index for <u>food</u> increased by 0.8%, 0.8%, 0.9% and 0.9% in the Composite CPI, CPI(A), CPI(B) and CPI(C) respectively, largely due to the increases in the costs for meals bought away from home.

- 4.8 <u>電力、燃氣及水</u>指數在綜合及乙類消費物價指數中分別上升1.0%及2.0%,主因是更多住戶已用完政府所提供的一次性電費補貼及煤氣的燃料調整費上升。同時,<u>電力、燃氣及水</u>指數在甲類及丙類消費物價指數中分別上升0.5%及0.4%,這是由於煤氣的燃料調整費上升。

- 4.9 <u>煙酒</u>指數在乙類及丙類消費物價指數中 均下跌0.1%,這是洋酒價格下跌所致。而<u>煙酒</u>指 數在綜合及甲類消費物價指數中則維持不變。
- 4.10 <u>衣履</u>指數在綜合、甲類、乙類及丙類消費物價指數中分別下跌2.4%、1.7%、2.2%及3.2%,主因是外衣價格下跌。

- (i) Meals bought away from home The average costs for meals bought away from home increased by 0.7% in all the four CPIs.
- 4.6 The average retail prices and price ranges of selected food items for the current month, preceding month and same month in preceding year are shown in <u>Table 8</u>.
- 4.7 The index for <u>housing</u> increased by 0.5%, 0.5%, 0.5% and 0.3% in the Composite CPI, CPI(A), CPI(B) and CPI(C) respectively. This was mainly attributable to the increases in private housing rentals.
- 4.8 The index for electricity, gas and water increased by 1.0% and 2.0% in the Composite CPI and CPI(B) respectively. This was mainly because more households had used up the full amount of Government's one-off electricity charge subsidy as well as the increases in the fuel cost variation charge for towngas. Meanwhile, the index for electricity, gas and water increased by 0.5% and 0.4% in the CPI(A) and CPI(C) respectively. This was because of the increases in the fuel cost variation charge for towngas.
- 4.9 The index for <u>alcoholic drinks and tobacco</u> all decreased by 0.1% in the CPI(B) and CPI(C). This was because the prices of foreign-style wines decreased. Meanwhile, the index for <u>alcoholic drinks and tobacco</u> remained unchanged in the Composite CPI and CPI(A).
- 4.10 The index for <u>clothing and footwear</u> decreased by 2.4%, 1.7%, 2.2% and 3.2% in the Composite CPI, CPI(A), CPI(B) and CPI(C) respectively. This was mainly attributable to the decreases in the prices of outerclothing.

- 4.11 耐用物品指數在綜合及乙類消費物價指數中均下跌0.1%,主要是影音器材價格下跌所致。同時,耐用物品指數在丙類消費物價指數中下跌0.1%,主要是由於家具價格下跌。但指數在甲類消費物價指數中則上升0.1%,主因是旅行及體育用品價格上升。
- 4.12 雜項物品指數在綜合及丙類消費物價指數中分別上升0.2%及0.3%,主要是首飾價格上升所致。同時,雜項物品指數在甲類及乙類消費物價指數中均上升0.2%,主要是由於其他家庭用品價格上升。
- 4.13 <u>交通</u>指數在綜合、甲類、乙類及丙類消費物價指數中分別上升0.5%、0.3%、0.5%及0.7%,主要是進出香港交通費用及汽油價格上升所致。
- 4.14 <u>雜項服務</u>指數在綜合、甲類、乙類及丙類 消費物價指數中分別上升1.2%、0.6%、1.4%及 1.3%,主因是旅遊費用上升。
- 4.15 四項消費物價指數的商品/服務組別指數 在二零一零年十二月份的按月變動情況分別顯 示於表3(甲)至3(丁)。
- 4.16 各商品/服務類別指數在消費物價指數整體按月變動中所佔的比率列載於表6°至於佔消費物價指數整體變動中最大比率的商品/服務組別則在表7(甲)至7(丁)列出。

- 4.11 The index for durable goods all decreased by 0.1% in the Composite CPI and CPI(B). This was mainly because of the decreases in the prices of video and sound equipment. Meanwhile, the index for durable goods decreased by 0.1% in the CPI(C). This was largely because the prices of furniture decreased. However, the index increased by 0.1% in the This was mainly attributable to the CPI(A). increases in the prices of travel and sports goods.
- 4.12 The index for <u>miscellaneous goods</u> increased by 0.2% and 0.3% in the Composite CPI and CPI(C) respectively. This was largely because the prices of jewellery increased. Meanwhile, the index for <u>miscellaneous goods</u> all increased by 0.2% in the CPI(A) and CPI(B). This was mainly because of the increases in the prices of other household goods.
- 4.13 The index for <u>transport</u> increased by 0.5%, 0.3%, 0.5% and 0.7% in the Composite CPI, CPI(A), CPI(B) and CPI(C) respectively. This was mainly attributable to the increases in the inbound and outbound transport fares and the prices of motor fuel.
- 4.14 The index for <u>miscellaneous services</u> increased by 1.2%, 0.6%, 1.4% and 1.3% in the Composite CPI, CPI(A), CPI(B) and CPI(C) respectively. This was mainly attributable to the increases in the charges for package tours.
- 4.15 The month-to-month movements of the four CPIs for December 2010 by commodity/service group are shown in $\underline{\text{Tables}}$ $\underline{3(A) \text{ to } 3(D)}$ respectively.
- 4.16 The contribution of each commodity/service section to the overall month-to-month change in the CPIs is presented in <u>Table 6</u>. The commodity/service groups with the largest contributions to the overall change in CPIs are listed in Tables 7(A) to 7(D).

5. 經季節性調整的消費物價指數

- 5.1 消費物價指數原來數列的按月變動率會受到季節性變異的影響。把這些季節性變異從數列中剔除,便可更有意義地比較相連月份數字。
- 5.2 經季節性調整的數列可因應數據增加而作 出修訂。由二零零四年十月開始,每年發表十月 份的數字時,會一併修訂對上三年的經季節性調 整消費物價指數。
- 5.3 自二零零八年十月開始,編製經季節性調整的消費物價指數的方法由過往「X-11自迴歸-求和-移動平均(X-11 ARIMA)」方法更改爲「X-12 自迴歸-求和-移動平均(X-12 ARIMA)」方法。自二零零五年十月開始的經季節性調整的消費物價指數數列亦已按這個新方法作出修訂。「X-12自迴歸-求和-移動平均」方法改良自「X-11自迴歸-求和-移動平均」方法改良自「X-11自迴歸-求和-移動平均」方法,能提供更佳的模型建造及模型評估能力。「X-12自迴歸-求和-移動平均」方法現時是很多國家/地區的統計機構用作編製經季節性調整統計數列的標準方法。
- 5.4 <u>表4(甲)及(乙)</u>列載經季節性調整的消費物 價指數在過去三年的按月變動率。
- 5.5 參考經季節性調整的指數在最近三個月內的平均按月變動率,能更清楚看到消費物價指數的趨勢。如下頁的表戊顯示,就綜合消費物價指數而言,這變動率在二零一零年十二月份爲1.0%,與十一月份相同。但應留意這些變動率是受到個別政府一次性紓困措施只在某些月份實施所影響。剔除這些影響,在二零一零年十至十二月的三個月內,綜合消費物價指數的平均每月變動率爲0.4%,與二零一零年九至十一月的三個月內的相應變動率相同。

5. Seasonally adjusted CPIs

- 5.1 Month-to-month rates of change based on the original CPI series are affected by seasonal variations. By removing these seasonal variations from the series, figures for consecutive months can be compared more meaningfully.
- 5.2 Seasonally adjusted series may be revised as more data become available. Starting from October 2004, the seasonally adjusted CPIs for the preceding three years are revised each year when releasing the figures for October.
- 5.3 Starting from October 2008, the seasonal adjustment of the CPI is compiled by the X-12 ARIMA method to replace the previous X-11 ARIMA method. The seasonally adjusted CPI series since October 2005 have also been revised using the new method. X-12 ARIMA method is an update to the X-11 ARIMA method with enhanced modelling and diagnostic capabilities. The X-12 ARIMA method has now been a standard method used by statistical offices for performing seasonal adjustment of statistical series in many countries/territories.
- 5.4 The month-to-month rates of change of the seasonally adjusted CPIs in the past three years are presented in $\underline{\text{Tables 4(A) and (B)}}$.
- The trend of the CPIs may be more clearly discerned by looking at the average monthly rate of change of the seasonally adjusted indices during the latest 3 months. As shown in Table E on the next page, such rate of change in the Composite CPI was 1.0% in December 2010, same as that in November. It should be noted that these rates of change were affected by Government's one-off relief measures implemented only in some months. Netting out these effects, the corresponding average monthly rate of change in the Composite CPI for the 3-month period from October to December 2010 was 0.4%, same as those for the 3-month period from September to November 2010.


Chart 2 Consumer Price Indices at all-item level (Oct. 2004 - Sep. 2005 = 100)









Chart 3 Consumer Price Indices at commodity/service section level (Oct. 2004 - Sep. 2005 = 100) (Cont'd)










