闡釋香港的整體國際收支和儲備資產 Interpreting the Overall Balance of Payments and Reserve Assets of Hong Kong

國際收支平衡統計數字,對貨幣和金融事務監察,以及本地及國際間不同範疇的政策審議方面,均非常重要。當分析國際收支平衡表的時候,通常首先是着眼於整體國際收支。整體國際收支是經常帳差額和非儲備性質的資本及金融帳淨值的總和,加以淨誤差及遺漏所得出。換言之,整體國際收支反映儲備資產的交易變化。因此,分析整體國際收支及儲備資產的交易淨值應一併進行。

Balance of Payments (BoP) statistics are important for monetary and financial monitoring and policy deliberations in different areas in both local and international contexts. 闡釋香港的整體國際收支和儲備資產 Interpreting the Overall Balance of Payments and Reserve Assets of Hong Kong

1. 引言

- 1.1 國際收支平衡統計數字,對貨幣和金融 事務監察,以及本地及國際間不同範疇的政策 審議方面,均非常重要。這些數據亦提供客觀 的基礎以判斷一個經濟體系的經濟狀況,以及 評估其金融系統的健全性。國際收支平衡數據 不單是商業及投資決策的重要元素,亦有助於 對一個經濟體系進行不同角度的宏觀經濟分 析。
- 1.2 當分析國際收支平衡表的時候,通常首 先是着眼於整體國際收支。整體國際收支是經 常帳差額和非儲備性質的資本及金融帳淨値 的總和,加以淨誤差及遺漏所得出。換言之, 整體國際收支反映儲備資產的交易變化。因 此,分析整體國際收支及儲備資產的交易淨値 應一倂進行。
- 1.3 本文簡略解釋整體國際收支的含義及其 對評估對外收支情況的闡釋,以及介紹香港在 過去十年整體國際收支和儲備資產的要點。

2. 整體國際收支概念

2.1 國際收支平衡表是有系統地載錄在指定期間內,某經濟體系與世界各地的各類經濟交易的統計表。完整的國際收支平衡表包括以下兩個主要核算帳: (甲)經常帳;及(乙)資本及金融帳。

1. Introduction

- 1.1 Balance of Payments (BoP) statistics are important for monetary and financial monitoring and policy deliberations in different areas in both local and international contexts. Such data also provide an objective basis for gauging the economic situation and in assessing the financial soundness of an economy. Not only are BoP data crucial elements for many business and investment decisions, but they also facilitate macroeconomic analysis of different aspects of an economy.
- 1.2 In analysing the BoP account, the first glance is often at the overall balance of payments (or overall BoP balance). The overall BoP balance represents the sum of balances of the current account and the non-reserve portion of the capital and financial account, plus net errors and omissions (NEO). In other words, the overall BoP balance is the mirror image of transaction changes in reserve assets. Hence, the analysis and interpretation of the overall BoP balance and that of the net transactions of reserve assets should be taken together.
- 1.3 This article briefly explains the conceptual meaning of the overall BoP balance and its interpretation in assessing the external payment conditions. It also presents the salient features of the overall BoP balance and reserve assets of Hong Kong in the past decade.

2. Concept of the Overall BoP Balance

2.1 A BoP account is an integrated statistical statement that systematically summarises, for a specific time period, the economic transactions of an economy with the rest of the world. A complete BoP account comprises two broad accounts: (a) the current account; and (b) the capital and financial account.

- 2.2 根據複式記帳制,每項交易均由相反符號而價值相等的兩項帳目(貸方(+)及借方(-))所代表。原則上,貸方帳目之總和與借方帳目之總和應該是相等的。換句話說,所有貸方和借方帳目的淨總和應相等於零。這意味着國際收支平衡表內所有支出及收入應該是相等的。
- 2.3 但實際上,由於資料須透過很多不同的來源和方法搜集,貸方和借方帳目不能完全相等。這個統計差異便須加進一個餘額項目,以反映平衡表的淨誤差及遺漏。
- 2.4 當分析國際收支平衡表時,可在國際收支平衡表上劃上一條橫線,將帳項分成兩組 —— 一組在線上而另一組則在線下,便得到國際交易的差額,以便分析國際收支平衡表中不同組別項目的聯繫及相互關係。所劃的橫線越低,被包括在線上的差額的國際交易會越多。根據上述的複式記帳制,在線上及線下的差額會是相反符號而價值相等。「淨貸方」的差額傳統上稱爲"盈餘";而「淨借方」則稱爲"赤字"。因此,若說某經濟體系的國際收支平衡是赤字或盈餘,其必涉及平衡表內某些特定的交易組別。
- 2.5 以下是一些常見的盈餘或赤字差額項目:經常帳差額,有形貿易(貨物貿易)差額,無形貿易(服務貿易)差額,或以上各項及其他國際交易的任何組合。舉例說,經常帳的盈餘/赤字應有等值的資本及金融帳的赤字/盈餘,加以淨誤差及遺漏。

- 2.2 Based on the double-entry accounting system, every transaction is represented by two entries, a credit (+) and a debit (-), with equal value but opposite sign. In principle, the sum of all credit entries should always equal to the sum of all debit entries. In other words, the net sum of all credit and debit entries should always add up to zero. That means the values of all payments and receipts in the BoP account should always be in balance.
- 2.3 In practice, however, the credit and debit entries do not balance exactly as data are collected from different sources and methods. This statistical discrepancy is thus reflected by NEO, which is the amount needed to bring the credit and the debit sides of the statement back to equality.
- In analysing the BoP account, a net balance of international transactions may be obtained by drawing a line horizontally to divide the BoP statement into two groups of items - one above the line and the other below the line. This enables the analysis of linkages and interrelationship of different groups of items in the BoP account. The lower the line is drawn, the more inclusive the net balance above the line becomes. The net balance of the items above the line will always be numerically equal, but opposite in sign, to the net balance of the items below the line, due to the double-entry accounting principle described earlier. A net credit of these balances is conventionally termed a "surplus" while a net debit a "deficit". Thus, the statement that an economy has a deficit or surplus in its "balance of payments" must refer to some specified group of transactions.
- 2.5 It is common to refer to a surplus or deficit in any of the following net balances: current account balance, visible trade (trade in goods) balance, invisible trade (trade in services) balance, or any combination of these or other international transactions. For example, a surplus/deficit in the current account balance should correspond to an equivalent deficit/surplus in the capital and financial account balance, plus NEO.

- 2.6 同樣,若將橫線僅畫在儲備資產之上, 在線上的差額將代表經常帳和資本及金融帳 內的非儲備部分的所有項目,加以淨誤差及遺 漏的總和,便是整體國際收支。在線下的差 額,即儲備資產,便會與線上數值的差額相等 而符號相反。因此,整體國際收支反映儲備資 產的交易變化。
- 2.7 如整體國際收支錄得 10 億元盈餘(貸 方),這意味着儲備資產增加了 10 億元(借 方)。因此,分析整體國際收支及儲備資產的 交易淨值應一併進行。

3. 對整體國際收支的闡釋

- 3.1 整體國際收支概括了在一個特定期間內進入或離開香港的資金流動。整體國際收支盈餘意指香港在進行貨物、服務、收益及資產的對外交易,以及在對外轉移中,所收取的外匯比支付的多。換言之,整體國際收支盈餘反映在該期間從世界各地的資金淨流入。相反,整體國際收支赤字表示支付的外匯比收取的多及反映在期間的資金淨流出。然而,由於整體國際收支涵蓋的交易廣泛,在闡釋國際收支平衡表時,應對其內容(即在橫線上的組成部分)作詳細的研究。
- 3.2 儲備資產是指一個經濟體系的金融當局可直接用來支付對外收支的不平衡,及用於干預外匯市場以影響該經濟體系的匯率,從而間接調節該等收支不平衡的對外資產。

- 2.6 Similarly, by drawing a line just above reserve assets, the net balance above the line would represent the sum of all entries of the current account and the non-reserve portion of the capital and financial account plus NEO, which is the overall BoP balance. The balance below the line, which is reserve assets, would be equal in value but in opposite sign to that above the line. The overall BoP balance is thus the mirror image of transaction changes in reserve assets.
- 2.7 For example, if there is a surplus in the overall BoP balance of \$1 billion (credit), it means that reserve assets have been increased by \$1 billion (debit). Hence, the analysis and interpretation of the overall BoP balance and that of the net transactions of reserve assets should be taken together.

3. Interpretation of the Overall BoP Balance

- The overall BoP balance summarises the flow 3.1 of funds from, or to Hong Kong for a reference period. An overall BoP surplus means that Hong Kong receives more foreign currencies than it pays in external transactions in goods, services, income and assets, as well as in external transfers. In other words, a BoP surplus reflects an overall net inflow of funds from the rest of the world during the period. Conversely, an overall BoP deficit means that Hong Kong pays more foreign currencies than it receives in external transactions, and reflects an overall net outflow of funds to the rest of the world during the period. Nevertheless, since the overall BoP covers a wide range of transactions, its contents (the above-the-line components) should be thoroughly studied as well when interpreting the BoP account.
- 3.2 Reserve assets consist of external assets that are readily available to and effectively controlled by the monetary authorities of an economy for directly financing payment imbalances and for indirectly regulating the magnitude of such imbalances through intervention in the foreign exchange markets to affect the currency exchange rate of that economy.

- 3.3 儲備資產交易在傳統上被認為是調節交易,運用外幣支付經常帳和非儲備性質的資本及金融帳內所有自主交易的淨結餘。這些交易也反映了由整體國際收支盈餘/赤字引致外幣(兌換本地貨幣)的供應/需求過剩時,官方為了穩定匯率而對外匯市場作出的干預。
- 3.4 然而,儲備資產變動淨值亦反映了現今經濟體系對儲備資產的積極管理,以及爲達致不同政策目標的其他自主交易。例如,將財政盈餘轉化爲對外資產是影響香港儲備資產活動的其中一個原因。自一九七六年開始,庫務署便將財政儲備轉撥到外匯基金以兌換爲有息債務證明書。庫務署可隨時按需要運用這些儲備以應付政府一般收入帳目所需。

4. 一九九九年至二零零八年整體國際收支及儲備資產要點

4.1 表一顯示一九九九年至二零零八年按標準組成部分劃分的香港國際收支平衡表。除二零零二年外,香港的整體國際收支於一九九九年至二零零八年均錄得盈餘。儲備資產於各錄得盈餘的年份相應增加同樣數額。

- 3.3 Transactions in reserve assets are traditionally considered to be accommodating transactions, conducted by using foreign currencies to finance the net effect of all autonomous transactions in the current account and the capital and financial (non-reserve assets) account. These transactions also reflect official intervention in foreign exchange markets to stabilise the exchange rate of domestic currency when excess supply/demand of foreign currencies (traded against domestic currency) arises together with an overall BoP surplus/deficit.
- 3.4 Nevertheless, net changes of reserve assets in a modern economy may also reflect active management of reserve assets and other autonomous transactions for achieving various policy objectives. For instance, the conversion of fiscal surpluses into foreign assets is one of the factors influencing movements of reserve assets in Hong Kong. Since 1976, the Treasury has begun to transfer fiscal reserves to the Exchange Fund in exchange for interest-bearing debt certificates. These reserves are repaid to the Treasury as and when required to meet the obligations of the General Revenue.

4. Salient Features of the Overall BoP Balance and Reserve Assets, 1999 to 2008

4.1 Table 1 shows Hong Kong's BoP account analysed by standard component from 1999 to 2008. Overall BoP surpluses were generally recorded during the period 1999 to 2008, except 2002. Reserve assets correspondingly increased by the same amount in the years where overall BoP surpluses were recorded.

- 4.2 儲備資產的積存是經常帳和非儲備性質的資本及金融帳不同組合的結果。例如,經常帳盈餘(+)和非儲備性質的資本及金融帳淨流入(+)的組合必定能產生儲備資產的積存(-)。此外,經常帳盈餘(+)和非儲備性質的資本及金融帳的淨流出(-)的組合,只要經常帳盈餘大過非儲備性質的資本及金融帳的淨流出,亦能產生儲備資產的積存(-)。同樣,如非儲備性質的資本及金融帳的淨流入較經常帳赤字爲大,經常帳赤字(-)和非儲備性質的資本及金融帳的淨流入較經常帳赤字爲大,經常帳赤字(-)和非儲備性質的資本及金融帳的淨流入較經常帳赤字爲大,經常帳赤字(-)和非儲備性質的資本及金融帳的淨流入(+)的組合亦能產生儲備資產的積存(-)。
- 4.3 除二零零二年外,一九九九年至二零零八年期間,香港均錄得整體國際收支盈餘。在 橫線以上的組成部分的檢查顯示,所有整體國 際收支盈餘均有經常帳盈餘的特徵。不過,在 該期間的非儲備性質的資本及金融帳的活動 則顯示出不同的情況。 (圖一)
- 4.4 以下將對錄得相對顯著的整體國際收支 盈餘的二零零七年和二零零八年作對比。
- 4.5 二零零七年的整體國際收支錄得 1,145 億元盈餘(相當於本地生產總值的 7.1%)。這是由於經常帳的 1,992 億元盈餘(相當於本地生產總值的 12.3%)被非儲備性質的資本及金融帳的 1,447 億元淨流出(相當於本地生產總值的 9.0%)部分抵銷。淨流出主要是由於金融資產的淨獲得(流出)較債務的淨產生(流入)爲大,尤其是其他投資。

- 4.2 The accumulation of reserve assets can reflect different patterns in the current account and the capital and financial (non-reserve assets) account. For example, a current account surplus (+) combined with a net inflow (+) in the capital and financial (non-reserve assets) account can result in the accumulation of reserve assets (-). Besides, a current account surplus (+) combined with a net outflow (-) in the capital and financial (non-reserve assets) account can also result in the accumulation of reserve assets (-), provided that the current account surplus is more than compensating the net outflow in the capital and financial (non-reserve assets) account. Similarly, a current account deficit (-) combined with a net inflow (+) in the capital and financial (non-reserve assets) account can as well result in the accumulation of reserve assets (-), if the net inflow in the capital and financial (non-reserve assets) account is larger than the current account deficit.
- 4.3 For the overall BoP surpluses of Hong Kong recorded during the period 1999 to 2008, except 2002, an examination of the above-the-line components revealed that all these BoP surpluses were characterised by current account surpluses. Nevertheless, different patterns in the capital and financial (non-reserve assets) account were observed in this period. (Chart 1)
- 4.4 Take 2007 and 2008, in which relatively significant BoP surpluses were registered, as two contrasting examples below.
- 4.5 In 2007, an overall BoP surplus of \$114.5 billion (at 7.1% of GDP) was recorded. This was attributable to a current account surplus of \$199.2 billion (at 12.3% of GDP), partly offset by a net outflow of capital and financial non-reserve assets of \$144.7 billion (at 9.0% of GDP). The net outflow was mainly due to a net acquisition of financial assets (outflow) which was larger than a net incurrence of liabilities (inflow), particularly for other investment.

- 4.6 二零零八年的整體國際收支錄得 2,639 億元盈餘(相當於本地生產總值的 15.7%)。 這是由於經常帳的 2,392 億元盈餘(相當於本地生產總值的 14.3%)加上非儲備性質的資本及金融帳的 327 億元淨流入(相當於本地生產總值的 2.0%)所引致。淨流入主要是由於金融資產的淨拋售(流入)比債務的淨償還(流出)爲大,尤其是其他投資。
- 4.7 本港國際收支平衡表內有關儲備資產的數字反映香港金融管理局所管理外匯儲備資產的淨變動。外匯儲備資產變動淨值與國際收支平衡大致相若。它們的差別只在於計算價值的改變(即價格變動及匯率變動)及分類重組的效果。
- 4.8 外匯儲備資產頭寸從一九九九年的7,482 億元(相當於本地生產總值的59.1%)增加至二零零八年的14,147 億元(相當於本地生產總值的84.4%)。二零零七年的顯著增加是由於香港特別行政區政府的財政儲備及未償還的外匯基金票據和債券增加。而二零零八年的積存主要是銀行體系的總結餘及未償還的外匯基金票據和債券增加所致。這些外匯基金的負債及其他負債的擴張使儲備資產相應增加。(圖二)

- 4.6 In 2008, an overall BoP surplus of \$263.9 billion (at 15.7% of GDP) was recorded. This was attributable to a current account surplus of \$239.2 billion (at 14.3% of GDP), plus a net inflow of capital and financial non-reserve assets of \$32.7 billion (at 2.0% of GDP). The net inflow was mainly contributed by a net disposal of financial assets (inflow) which was larger than a net repayment of liabilities (outflow), particularly for other investment.
- 4.7 The change in reserve assets in the BoP account reflects the net change in Hong Kong's foreign currency reserve assets, which come under the management of the Hong Kong Monetary Authority. The change in foreign currency reserve assets corresponds closely to the change in the overall BoP balance. The difference between the change in foreign currency reserve assets and the change in the overall BoP balance was due to the effects of valuation changes (including price changes and exchange rate changes) and reclassifications.
- The position of foreign currency reserve assets 4.8 increased from \$748.2 billion (at 59.1% of GDP) at end 1999 to \$1,414.7 billion (at 84.4% of GDP) at end 2008. A significant accumulation of reserve assets was recorded in 2007 and 2008. significant increase in 2007 was largely attributable to an increase in fiscal reserves of the HKSAR government and the outstanding Exchange Fund Bills and Notes, while for 2008, the accumulation was mainly due to an increase in the Aggregate Balance of the banking sector and the outstanding Exchange Fund Bills and Notes. The expansion of these Exchange Fund's liabilities and other liabilities contributed to the corresponding accumulation of reserve assets. (Chart 2)






