# 香港居民婚姻狀況的趨勢 Trend in Marital Status of Hong Kong Population

Marriage behaviour is a subject of interest to both demographers and the general public as it affects family formation, family composition and fertility. # 香港居民婚姻狀況的趨勢 Trend in Marital Status of Hong Kong Population

#### 1. 引言

- 1.1 人口學家及普羅大眾均對結婚取態的課題感興趣,因爲人們在這方面的取態會影響家庭的組成、家庭結構及生育。一般相信在早年出生的人士比近年出生的人士傾向較早結婚。
- 1.2 為確認香港人口中存在這現象,政府統計處透過「綜合住戶統計調查」在二零一一年六月至八月期間搜集已婚人士的結婚年份的資料,連同從其他來源得到有關這課題的資料,這篇專題文章概述過去十年間香港人口的婚姻狀況趨勢。由於外籍家庭傭工不是研究的對象,隨後的分析中會撤除該類人士。

#### 2. 過去十年間婚姻狀況的趨勢

2.1 根據持續進行的「綜合住戶統計調查」 所搜集有關婚姻狀況的資料,在二零零零年至 二零一一年六月至八月期間,15 歲及以上已婚 男性佔所有同年齡組別男性的比例大致維持在 60%至 62%水平,十年間只輕微下跌 0.6 個百 分點。另一方面,15 歲及以上已婚女性的比例 則從二零零零年的 58.3%下降至二零一一年六 月至八月的 55.0%,下跌 3.3 個百分點。 (表一)

#### 1. Introduction

- 1.1 Marriage behaviour is a subject of interest to both demographers and the general public as it affects family formation, family composition and fertility. It is generally believed that persons born in earlier years got married earlier in their life while marriage postponement is more common among persons born in recent years.
- 1.2 To ascertain such phenomenon in Hong Kong population, information on "year of current marriage" for married persons was collected in the General Household Survey (GHS) during June-August 2011. Together with relevant information related to the subject from other sources, this feature article provides an overview of the trend in marital status of Hong Kong population in the past decade. Foreign domestic helpers are excluded in the ensuing analysis as they are not the target of the study.

## 2. Trend in Marital Status in the Past Decade

2.1 Based on the information on marital status collected in GHS on a continuous basis, the proportion of males aged 15 and over who were currently married among males of the same age group remained steady at the level from 60% to 62% during 2000 to June-August 2011, a mere drop of 0.6 percentage point over the period. On the other hand, the proportion of females aged 15 and over who were currently married decreased from 58.3% in 2000 to 55.0% in June-August 2011, or a decline of 3.3 percentage points over the period. 2.2 由於人口的年齡性別結構對已婚人士比例的多寡有很大影響,因而需要編製標準化百分比以剔除因不同年份的人口年齡性別結構有所不同而引致的影響。根據二零零零年的人口年齡性別結構作爲標準而計算,已婚人士的標準化比例呈現較顯著的下跌。已婚男性人口的標準化百分比從二零零零年的 62.2%下跌 4.6個百分點至二零一一年六月至八月的 57.6%。同期間已婚女性人口的標準化百分比亦下跌

2.2 As the proportion of currently married population is very much affected by the age-sex structure of the population, standardised percentages have to be computed to eliminate the effects arising from different age-sex structure of the population in different years under comparison. Using the age-sex structure of the population in 2000 as the standard, the standardised percentages of currently married population showed a more profound decrease. The standardised percentages of currently married males decreased by 4.6 percentage points from 62.2% in 2000 to 57.6% in June-August 2011 while that of the




2.3 在喪偶/離婚/分居者中,女性相對男性的比例在過去十年間大致維持在 3.5:1 至 3.6:1。該比例相對較高有三個主要原因。首先,男性死亡率較女性爲高,尤其是在年長人口中,因此寡婦數目比鰥夫數目爲多。第二,香港男性傾向與較自己年輕的女性結婚,從而加快寡居效應。第三,婚姻統計數字亦顯示在過去數年間,鰥夫比寡婦再婚的可能性較高。(圖一)




widowed/divorced/separated 2.3 Among the persons, the ratio of females to males was about 3.5:1 to 3.6:1 during 2000 to June-August 2011. The relatively high ratio was attributed to three main factors. Firstly, the higher male mortality rates over those of the females, particularly at the older ages, led to a larger number of widows than widowers. Secondly, Hong Kong men tended to marry wives who were younger than themselves, thereby hastening the state of widowhood. Thirdly, marriage statistics also revealed that in the past few years, widowers were more likely than widows to get re-married. (Chart 1)

2.4 除了從「綜合住戶統計調查」搜集有關香港人口的婚姻狀況的資料外,入境事務處也從結婚登記中搜集結婚(包括初婚及再婚)年齡的資料。男性的結婚年齡中位數從二零零零年的 31.1 歲上升至二零一零年的 33.2 歲,而女性的結婚年齡中位數從二零零零年的 27.9 歲上升至二零一零年的 29.8 歲。隨着越來越多男女接受較長時間的教育及較遲才踏進社會工作,兩性的結婚年齡中位數在過去十年均有所增加。值得注意的是,結婚年齡中位數是從某一年在入境事務處登記的結婚個案計算出來,並不是指一群相同年齡的人士的結婚年齡中位數。 (表二)

Other than collecting the information on marital status of the Hong Kong population via GHS, the Immigration Department collects information on age at marriage (including first marriage and re-marriage) through marriage registrations. median age at marriage was 33.2 for men in 2010, increasing from 31.1 in 2000. As for women, the median age at marriage was 29.8 in 2010, increasing from 27.9 in 2000. As increasingly more men and women stayed longer in education and started to work later, the median age at marriage increased for both gender in the past ten years. It should be noted that the median age of marriage is compiled from those marriages registered with the Immigration Department in a particular year, rather than the median age at marriage of a group of persons of the same age. #### 3. 已婚人士的結婚年份

3.1 為更好地描繪結婚年齡,「綜合住戶統計調查」在二零一一年六月至八月期間搜集不同年齡組群的已婚人士的結婚年份的資料。一個年齡組群是指一群相同年齡的人士,他們在人生過程中共享相似的特徵或經驗(例如:讀書、工作)。例如,一九三零年代初組群是指在一九三零年代初出生的人士,他們在十餘歲時經歷了第二次世界大戰,現在年齡為75至

# 3. Year of Current Marriage for Currently Married Persons


3.1 To portray a better picture on the age at marriage, information on year of current marriage for currently married persons of different age cohorts was collected in GHS during June-August 2011. An age cohort is a group of persons of the same age sharing similar characteristics or experience (e.g. schooling, work) during their life. For example, the early 1930s cohort refers to the group of persons born in the early 1930s. They experienced the Second World War in their teens and are now aged 75 to 79.

Taking another example, the commonly used term "Post-1980" in recent years refers to the 1980s cohort, comprising persons born in the 1980s. Once information on age and year of current marriage of currently married persons is available, statistics on age at marriage of an age cohort can be derived. This is termed the "cohort age at marriage" in order to distinguish this with the statistics on "period age at marriage" (i.e. age of a group of persons, irrespective of their age, who get married at a particular time point) presented in Table 2. Chart 2 shows the difference between cohort and period measurements.

- 3.2 即使組群結婚年齡的分析有助理解結婚 取態,很多研究仍會集中在期間分析(結婚的 年份)。這是由於我們需要等待該年齡組群內 的所有人士經歷過有關變量的變化後,組群分 析才會有用。例如,組群生命表只能在該年齡
- 3.2 Even though analysis on cohort age at marriage is useful in understanding marriage behaviour, many studies still focus on period analysis (year of getting married) instead. The reason is that for cohort analysis to be useful, the age cohort needs to complete their exposure to the variable being studied. For

- 3.3 雖然如此,在結婚取態的研究中發現, 大部分人士會在 40 歲左右或以前結婚。因此, 隨後集中在一九四零年代至一九六零年代組群 的分析仍具參考價值,這些組群的人士現為 40 至 69 歲。有關一九三零年代組群(即 70 至 79 歲人士)和一九七零年代組群(即 30 至 39 歲 人士)的統計數據亦同時載列,以作參考。然 而,必須指出,一九三零年代組群中許多人士 已經去世,而一九七零年代組群中部分人士可 能會在較後時間結婚,所以有關他們結婚取態 的分析並非全面。
- 3.4 一九四零年代至一九六零年代組群的已婚男性中,他們在 25 至 29 歲結婚的比例維持在 37%左右,而在 30 至 34 歲結婚的比例從一九四零年代組群的 22.0%上升至一九六零年代組群的 26.6%。這顯示男性有輕微遲婚的情況。(表三)
- 3.5 至於已婚女性方面,她們在 20 至 24 歲結婚的比例從一九四零年代組群的 46.7%大幅下跌至一九六零年代組群的 34.2%。另一方面,她們在 25 至 29 歲結婚的比例從一九四零年代組群的 28.1%大幅上升至一九六零年代組群的 38.5%。這顯示女性有明顯遲婚的情況。(表三)

- example, a cohort life table can only be constructed when all persons in the age cohort died. This renders the cohort analysis not so useful as most demographers want to study the mortality patterns of persons born in recent years.
- 3.3 Nevertheless, in the study of marriage behaviour, most persons should have completed their marriage exposure at the age of 40 or so. Hence, the ensuing analysis concentrating on the 1940s to 1960s cohorts could still serve as a useful reference. Persons in these cohorts are now aged 40 to 69. Relevant statistics for the 1930s cohort (i.e. persons aged 70 to 79) and the 1970s cohort (i.e. persons aged 30 to 39) are also presented for reference. It should however be noted that the analysis of marriage behaviour of these cohorts are not comprehensive because many of the persons in the former cohort have already passed away while some in the latter cohort may get married later.
- 3.4 For currently married males of the 1940s to 1960s cohorts, the proportion of them getting married in the age group 25 to 29 was relatively steady at around 37% while the proportion of currently married males getting married in the age group 30 to 34 increased from 22.0% for the 1940s cohort to 26.6% for the 1960s cohort. This indicates a mild marriage postponement effect for males. (Table 3)
- 3.5 For currently married females, the proportion of them getting married in the age group 20 to 24 decreased sharply from 46.7% in the 1940s cohort to 34.2% in the 1960s cohort. On the other hand, the proportion of currently married females getting married in the age group 25 to 29 increased markedly from 28.1% in the 1940s cohort to 38.5% in the 1960s cohort. This indicates a strong marriage postponement effect for females. (Table 3)

3.6 一九四零年代至一九六零年代組群的男性組群結婚年齡中位數維持在 28 至 29 歲左右。這顯示男性並沒有遲婚的情況。表二載列的男性期間結婚年齡中位數的上升部分原因可能受在某一年結婚的男士的年齡結構的變化所影響。 (表四)

3.7 另一方面,女性組群結婚年齡中位數從 一九四零年代組群的 23 歲增加至一九六零年 代組群的 26 歲。這顯示遲婚的情況。一九七零 年代女性組群的結婚年齡中位數現時為 27 歲。當她們全部完成婚姻歷程後,這組群的結 婚年齡中位數將進一步上升。 (表四) 3.6 The median cohort age at marriage for males remained relatively stable at around 28 to 29 for the 1940s to 1960s cohorts. No postponement of marriage for males was observed. The apparent increase in the median period age at marriage for males presented in Table 2 may be partly attributable to the changes in age composition of males getting married in a particular year. (Table 4)

3.7 On the other hand, the median cohort age at marriage for females increased from 23 in the 1940s cohort to 26 in the 1960s cohort. This indicates the marriage postponement effect. The median cohort age at marriage for females was already 27 for the 1970s cohort at present. After they have all completed their marriage exposure, the median for this group of persons will increase further. (Table 4)

#### 4. 分析的局限

4.1 由於「綜合住戶統計調查」只涵蓋陸上 非住院人口,已婚人士的結婚年齡分析也只局 限於該類人士。由於部分在較早年齡組群的人 士爲居住在院舍的長者,統計調查未能搜集他 們的結婚年齡資料。此外,部分人士由於記憶 或健康問題等原因而無法提供資料。儘管如 此,這篇專題文章的分析仍然有其參考價值, 或可進一步作爲分析香港人口的生育或離婚趨 勢之用。

#### 4. Limitations of analysis

4.1 Since GHS only covers the land-based non-institutional population (LBNP), the analysis on the age at marriage of currently married persons is also confined to LBNP only. Information on age at marriage of some persons in the earlier age cohorts cannot be obtained as they are now elderly and reside in institutions. Moreover, some persons were unable to provide information owing to such reasons as memory lapse or health problems. Notwithstanding the above, the analysis presented in this feature article should still be useful for reference, or can be used as further input in the analysis of fertility or divorce trends of Hong Kong population.
