This article gives an overview of the provision, utilisation and latest developments of the public library services in Hong Kong.

香港公共圖書館服務槪覽 An Overview of the Public Library Services in Hong Kong

1. 引言

- 1.1 根據《聯合國教育、科學及文化組織公共圖書館宣言》中所載的信念,公共圖書館是開展教育、傳播文化和提供資訊的有力工具,也是在人民的思想中樹立和平觀念和豐富人民大眾精神生活的重要工具。
- 1.2 香港的公共圖書館服務由康樂及文化事務署(康文署)負責提供,以滿足社會在知識、資訊和研究方面的需求;支持市民終身學習、持續進修和善用餘暇;以及推廣本地文學藝術。
- 1.3 本文介紹香港的公共圖書館服務、其使 用情況,以及最新的發展。

2. 香港公共圖書館系統

- 2.1 香港公共圖書館系統由67間固定圖書館 和10間流動圖書館所組成。這些不同規模及類 型的圖書館平均分布於香港各個區域,通過一 個綜合圖書館系統連接起來,爲不同年齡及階 層的讀者提供便捷的圖書館服務。
- 2.2 在77間公共圖書館當中,33間(佔總數的43%)位於新界區;26間(34%)位於九龍區;以及18間(23%)位於港島區。
- 2.3 香港的公共圖書館提供多項不同的服務和設施。所有公共圖書館均免費提供外借圖書館資料服務,大部分的公共圖書館也有提供其他服務和設施。這些服務和設施包括兒童圖

1. Introduction

- 1.1 The United Nations Educational, Scientific and Cultural Organisation (UNESCO) Public Library Manifesto proclaims the belief in the public library as a living force for education, culture and information, and as an essential agent for the fostering of peace and spiritual welfare through the minds of men and women.
- 1.2 Provision of public library services in Hong Kong is under the purview of the Leisure and Cultural Services Department (LCSD). The Department aims to provide public library services to meet the community's need for knowledge, information and research, to support life-long learning, continuous education and profitable use of leisure time, and to promote local literary arts.
- 1.3 This article gives an overview of the provision, utilisation and latest developments of the public library services in Hong Kong.

2. The Public Library System in Hong Kong

- 2.1 The Hong Kong Public Libraries (HKPL) system consists of a network of 67 static and 10 mobile libraries. These libraries, of different scale and type, are evenly located over the territory. They are interconnected by an integrated library system to provide convenient access to library services for people of all age groups and walks of life.
- 2.2 Among the 77 public libraries, 33 (43% of the total) are located in the New Territories; 26 (34%) in Kowloon; and 18 (23%) on Hong Kong Island.
- 2.3 A wide range of services and facilities are provided by the public library network. While free lending of library materials is available from all the public libraries, other services and facilities are also offered by most of the public libraries. Such

- 2.4 大體來說,全港77間公共圖書館按其服務範圍和規模及館藏量分爲五個不同等級:
- (i) 香港中央圖書館;
- (ii) 五間主要圖書館;
- (iii) 29間分區圖書館;
- (iv) 32間小型圖書館;以及
- (v) 10間流動圖書館。
- 2.5 香港中央圖書館於二零零一年五月啓用,是本港最大的公共圖書館,也是本港主要的參考及資訊中心,館藏量超過200萬項。除了標準的圖書館設施及服務外,香港中央圖書館亦設有一所由六個不同專科部門組成的中央參考圖書館;兒童圖書館、青少年圖書館、玩具圖書館和藝術資源中心各一所,以及展覽館和演講廳等可供租用的設施。 (表一)
- 2.6 香港共有五間主要圖書館,即大會堂公共圖書館、九龍公共圖書館、沙田公共圖書館、荃灣公共圖書館和屯門公共圖書館。除提供全面的圖書館服務外,每一間主要圖書館均設有獨立的參考圖書館。29間分區圖書館是公共圖書館網絡的主要骨幹,爲18區市民提供多元化的圖書館服務及設施。32間小型圖書館則爲所屬地區的讀者提供基本圖書館服務,以進一步支援圖書館服務。(表一)
- 2.7 在那些無法設置固定圖書館的社區,則 設有10間流動圖書館,爲居住在沒有固定圖書 館的地區及偏遠地區的市民提供方便快捷的圖 書館服務。 (表一)

services and facilities include children's libraries, newspapers and periodicals services, reference and information services, computer and information centres, multi-media resource centres, students' study rooms, outreach programmes and block loan services.

- 2.4 Broadly speaking, the 77 public libraries are classified into five tiers according to their scope and level of services and size of collection:
- (i) Hong Kong Central Library (HKCL);
- (ii) five major libraries;
- (iii) 29 district libraries;
- (iv) 32 small libraries; and
- (v) 10 mobile libraries.
- 2.5 The HKCL, opened in May 2001, is the largest public library in Hong Kong. Offering a total stock of more than 2 million items, the HKCL is also the major reference and information centre in Hong Kong. In addition to standard library facilities and services, HKCL provides a central reference library of 6 subject departments, a children's library, a young adult library, a toy library, an arts resource centre and hiring facilities comprising an exhibition gallery and a lecture theatre. (Table 1)
- 2.6 There are 5 major libraries, namely, City Hall Public Library, Kowloon Public Library, Sha Tin Public Library, Tsuen Wan Public Library and Tuen Mun Public Library. In addition to comprehensive library services, each major library provides a dedicated reference library. The 29 district libraries, as the major backbone of the public library network, offer a wide range of library services and facilities in the 18 districts. The library service is further supported by the 32 small libraries which provide basic library services to users at the local communities. (Table 1)
- 2.7 For those neighbourhoods where provision of static libraries is not feasible, the 10 mobile libraries enable people living in areas without static libraries and those living in remote areas to gain access to library services in a convenient manner. (Table 1)

- 2.8 康文署透過增加圖書館的數目及豐富圖書館館藏,不斷改善公共圖書館服務。公共圖書館的數目由二零零一年的69間,增加至二零一一年的77間。此外,圖書館的書籍及多媒體資料更由二零零一年的937萬項大幅增加至二零一年的1264萬項。 (表二)
- 2.8 The LCSD continuously improves its public library services through increasing the number of libraries and enriching its library collection. The network expanded to 77 public libraries in 2011, as compared with 69 in 2001. Besides, the stock of library books and multimedia materials tremendously increased from 9.37 million in 2001 to 12.64 million in 2011. (Table 2)

3. 電腦化圖書館服務

- 3.1 香港公共圖書館已全面電腦化,其電腦系統是全球最大型的圖書館電腦系統之一。該系統通過公共圖書館網系統之一。該系統通過公共圖書館網站(www.hkpl.gov.hk),全日24小時提供一系列網上圖書館服務。這些服務包括線上檢索目錄;使用電子資料;及預約和續借圖書館資料。
- 3.2 香港公共圖書館現時擁有超過10萬冊電子書,另備有約60個線上資料庫,提供不同類別的參考資料、統計資料和專門資料。香港公共圖書館的登記讀者可隨時隨地經公共圖書館網站(www.hkpl.gov.hk)免費閱覽所有電子書和13個線上資料庫。
- 3.3 此外,各區圖書館設置了逾1 700個可接駁互聯網的電腦工作站,供市民使用。所有固定公共圖書館亦提供免費無線上網服務。

3. Computerised Library Services

- 3.1 The HKPL has been fully computerised, and its Library Automation System is one of the world's largest computerised library systems. It provides a wide range of online library services through the HKPL's website (www.hkpl.gov.hk) round the clock. Such services include: online catalogue searching; access to electronic materials; and reservation and renewal of library materials.
- 3.2 At present, the HKPL has over 100 000 e-book items and about 60 online databases featuring different reference materials, statistical information and thematic information. Registered borrowers of the HKPL can access all e-books and 13 online databases via the HKPL's website (www.hkpl.gov.hk) free-of-charge anywhere anytime.
- 3.3 In addition, more than 1 700 computer workstations with Internet connection are available for public use in the libraries. Free Wi-Fi service is also available in all static public libraries.

4. 公共圖書館服務的使用情況

- 4.1 在二零一一年,香港公共圖書館的登記 讀者約400萬名。年內,全港77間公共圖書館 外借超過5 500萬項書籍及300萬項多媒體資 料。 (表三)
- 4.2 網上圖書館服務一直廣受市民大眾歡迎。在二零一一年,瀏覽公共圖書館網站的次數超過1.5億次。年內,網上續借數目達至大約1600萬,而網上預約數目為70萬。 (表三)

4. Utilisation of Public Library Services

- 4.1 The HKPL had about 4.0 million registered borrowers in 2011. During the year, over 55 million items of books and 3 million items of multimedia materials were borrowed from the 77 public libraries in Hong Kong. (Table 3)
- 4.2 Online library services have all along been popular among the public. In 2011, there were more than 150 million visits to HKPL's website. The number of Internet renewals reached some 16 million in 2011 and that for Internet reservations, 0.7 million. (Table 3)

註釋: ^ 外借圖書館資料及網上續借和預約的數目有所下降的原因包括: (一)由於部分圖書館閱讀環境有所改善,到館人流因而增加,越來越多讀者選擇/喜歡在圖書館內閱讀/使用圖書館資料而不外借它們。(二)學校對集體借閱服務的需求減少,因爲現在大部分學校已擁有自己的圖書館館藏。

Note: A Reasons for the decrease in the number of library materials borrowed, Internet renewals and Internet reservations include: (a) Patronage of some public libraries has increased along with enhancements in their reading environment. More and more people prefer reading/using the library items on the spot at the libraries to borrowing them; and (b) Demand for block loan service from schools has decreased as many of them have their own collection of library materials.

- 4.3 二零零七年至二零一一年按外借書籍種 類劃分的分析顯示,中文書籍較英文書籍受讀 者歡迎。 (表四)
- 4.4 在二零一一年,外借書籍的總數超過5500萬項,當中4400萬項(或80%)爲中文書籍。外借的中文書籍當中,以「語言學及文學」佔最多(佔外借中文書總數的44.2%),而這類別中以「小說」(19.6%)最受歡迎。外借的英文書籍當中,以「語言學」最受歡迎(佔外借英文書總數的23.8%),其次是「兒童圖畫書」(23.2%)和「兒童小說」(12.6%)。(表四)
- 4.3 Analysis by type of books borrowed from 2007 to 2011 indicated that Chinese books were more popular than English books. (Table 4)
- 4.4 In 2011, the number of books borrowed by the public was over 55 million items, of which 44 million items (or 80%) were Chinese books. Most Chinese books borrowed by the public were "Language and literature" (44.2% of the total Chinese books borrowed), of which "Fiction" (19.6%) was most popular. Of the English books borrowed, "Language" was most popular (or 23.8% of the total English books borrowed) followed by "Picture books" (23.2%) and "Junior Fiction" (12.6%). (Table 4)

5. 最新發展

- 5.1 香港公共圖書館會繼續善用資訊科技以優化其圖書館設施和服務。公共圖書館的系統提升工程進展順利,全新的圖書館電腦系統已於二零一一年十二月投入服務。
- 5.2 圖書館提供自助服務和應用無線射頻 識別技術已是世界趨勢。爲配合這情況,香港 公共圖書館自二零一一年年底開始以試驗性質 在六間公共圖書館應用無線射頻識別技術,爲 讀者提供自助借還書籍服務。如試驗計劃結果 令人滿意,便會籌備把該技術擴展至所有公共 圖書館。

6. 總結

6.1 香港公共圖書館系統在傳遞資訊及支援終身學習方面,一直擔當着重要的角色。近年,公共圖書館推出了多項嶄新的服務和計劃,其中包括延長圖書館開放時間;在三個港鐵主要轉車站提供還書箱設施;提供電腦化圖書館服務;提升圖書館電腦系統和應用無線射頻識別技術。康文署會繼續留意市民大眾的需要,以制訂適當的發展策略和服務指標,進一步改善公共圖書館服務。

5. Latest Developments

- 5.1 The HKPL continues to leverage on the use of information technology in enhancing its library facilities and services. The public library's system upgrade project is in smooth progress and a new library automation system has been put in place since December 2011.
- 5.2 In line with the worldwide trend of self-service and use of Radio Frequency Identification (RFID) technology in libraries, RFID technology has been deployed in 6 public libraries of HKPL on a trial basis since end-2011 for providing a self-service of borrowing and returning books. Plans for full deployment of RFID technology in all public libraries will be rolled out should the results of the trial scheme be satisfactory.

6. Conclusion

6.1 The public library system in Hong Kong has been playing an important role in the dissemination of information and the supporting of life-long learning in the community. In recent years, a number of new services and initiatives have been introduced. Among others, they include: extension of library opening hours; provision of book-drop facilities at three major Mass Transit Railway interchange stations; provision of computerised library service; upgrading of the Library Automation System; and use of RFID technology. The LCSD will continue to keep in view the needs of the community in order to devise suitable development strategies and service targets for the provision of better public library services.
