## 二零一一年失業率的走勢

## The Movement of the Unemployment Rate in 2011

勞工市場在二零零九年下半年開始轉好,受惠於經濟活動強勁增長及就業職位持續增加,勞工市場在二零一零年及二零一一年呈現廣泛而明顯的改善。隨着勞工需求增加,經季節性調整的失業率由二零零九年六月至八月 5.5%的高位逐步下降至二零一一年六月至八月的 3.2%,而二零一一年十月至十二月的數字則為 3.3%。本文旨在對二零一一年的失業率的轉變作多方面分析,從而令讀者對香港近期的失業情況有更清楚的了解。

Labour market conditions, having staged a gradual turnaround in the second half of 2009, witnessed widespread and notable improvements over the course of 2010 and 2011, amidst the strong pick-up in economic activity and substantial job creation. With improving labour demand, the seasonally adjusted unemployment rate decreased progressively from the peak at 5.5% in June – August 2009 to 3.2% in June – August 2011, and the figure for October – December 2011 was 3.3%. This article provides an analysis of the changes in unemployment rate in 2011 from various perspectives. It aims to give readers a better understanding about the recent unemployment situation in Hong Kong.

## The Movement of the Unemployment Rate in 2011

## 1. 引言

- 1.1 隨着本地經濟及對外貿易行業的商業活動受環球金融海嘯的影響而減慢,經季節性調整的失業率在二零零八年下半年開始回升,達至二零零九年六月至八月 5.5%的高位。香港經濟在二零零九年下半年有所改善,在二零一零年及二零一一年經濟更全面擴張。隨着勞工需求增加,失業人數在二零一一年大致上呈現下降趨勢。經季節性調整的失業率逐步下降至二零一一年六月至八月的 3.2%,而二零一一年十月至十二月的數字則爲 3.3%。
- 1.2 失業是社會關注的焦點之一。有關失業的統計量數對經濟情況提供一個指標,亦反映勞動力剩餘的程度。
- 1.3 有關失業的統計數字是根據「綜合住戶統計調查」獲取的數據而編製。「綜合住戶統計調查」每三個月期間的樣本規模約為24000 個住戶。在選中的住戶內,所有有關人士均被問及關於個人、勞動力和住戶特徵的資料。
- 1.4 本文旨在對二零一一年的失業率的轉變 作多方面分析,從而令讀者對香港近期的失 業情況有更清楚的了解。
- 1.5 採用二零一一年人口普查結果編製的二零一一年年底臨時人口估計已於二零一二年二月二十一日公布。二零零六年中期人口統計以後的人口估計的過往數列,已作出相應修訂。同樣地,二零零六年五月至七月及以後的勞動人口統計數列,亦已作出修訂。因此,本文內所載列的數字與二零一一年第一

#### 1. Introduction

- 1.1 The seasonally adjusted unemployment rate began to move up in the second half of 2008 and peaked at 5.5% in June August 2009, alongside the slowdown in business activities in both the domestic and external trade sectors due to the global financial tsunami. The Hong Kong economy then improved in the second half of 2009 and even staged a broadbased expansion in 2010 and 2011. In tandem with the upsurge in labour demand, unemployment was generally on the decline over the course of 2011. The seasonally adjusted unemployment rate came down progressively to 3.2% in June August 2011, and the figure for October December 2011 was 3.3%.
- 1.2 Unemployment is one of the focal issues of social concern. Statistical measures of unemployment provide an indication of the economic situation and also reflect the extent of unused capacity in the labour force.
- 1.3 Unemployment statistics are compiled based on data obtained from the General Household Survey (GHS). The sample size of the GHS is about 24 000 households in each three-month period. Information on personal, labour force and household characteristics is collected from all persons in the sampled households where appropriate.
- 1.4 This article provides an analysis of the changes in unemployment rate in 2011 from various perspectives. It aims to give readers a better understanding about the recent unemployment situation in Hong Kong.
- 1.5 The provisional population estimate for end-2011, with the results of the 2011 Population Census incorporated, was released on 21 February 2012. The past series of population estimates since the 2006 Population By-census have accordingly been revised. Likewise, the past series of labour force statistics since May July 2006 have been revised. Therefore, the figures published in this article may be different from those published in the first to third

2. 概念架構

- 2.1 有關勞動人口、就業、失業及就業不足等的統計數字,均是按照國際勞工組織建議的概念架構編製。該組織所訂定有關定義及其他相關事宜的建議,都是經過許多經濟、社會及統計學家和統計工作者作出研究和深入討論而得出的結果,自有其一定的合理性。而採用國際認可的定義編製的統計數字,才可作國際間的比較。
- 2.2 人口中的個別人士可按其經濟活動身分劃分爲從事經濟活動人口及非從事經濟活動人口兩大類。有關的概念和定義的詳細資料,請參閱本文第五節。

## 3. 失業率近年的變動

3.1 由於嚴重急性呼吸系統綜合症在二零零 三年三月至六月期間爆發,經季節性調整的 失業率在二零零三年四月至六月上升至 8.5% 的歷史性高位。勞工市場於二零零三年下半 年開始顯著改善,而經季節性調整的失業率 則持續下降,並於二零零八年四月至六月跌 至 3.2%。隨着本地經濟及對外貿易行業的商 業活動受環球金融海嘯的影響而減慢,經季 節性調整的失業率在二零零八年下半年開始 回升,達至二零零九年六月至八月 5.5%的高 位。香港經濟在二零零九年下半年有改善, 在二零一零年及二零一一年經濟更全面擴 張。隨着勞工需求增加,勞工市場在二零一 一年呈現廣泛而明顯的改善,經季節性調整 的失業率逐步下降至二零一一年六月至八月 的 3.2%, 而二零一一年十月至十二月的數字 則為 3.3%。

## 2. Conceptual Framework

- 2.1 Statistics on the labour force, employment, unemployment and underemployment are compiled in accordance with the conceptual framework recommended bv the International Labour Organization. The recommendations regarding definitions and other related issues have been based on research and in-depth discussions among many economists, sociologists, statisticians and statistical practitioners concerned, and are highly rational. Moreover, only statistics based on internationally accepted definitions are internationally comparable.
- 2.2 Individuals in the population can be divided into two main groups according to their economic activity status, viz. the economically active population and the economically inactive population. For details on the concepts and definitions, please see Section 5 of this article.

## 3. Changes in Unemployment Rate in Recent Years

As a result of the outbreak of the Severe Acute Respiratory Syndrome during March to June in 2003, the seasonally adjusted unemployment rate rose to the historical high of 8.5% in April – June 2003. The labour market showed distinct improvement as from the second half of 2003 and the seasonally adjusted unemployment rate continued to decrease and reached 3.2% in April – June 2008. unemployment rate began to move up in the second half of 2008 and peaked at 5.5% in June - August 2009, alongside the slowdown in business activities in both the domestic and external trade sectors due to the global financial tsunami. The Hong Kong economy then improved in the second half of 2009 and even staged a broad-based expansion in 2010 and 2011. In tandem with the upsurge in labour demand, the labour market conditions saw widespread and notable improvements over the course of 2011. The seasonally adjusted unemployment rate came down progressively to 3.2% in June - August 2011, and the figure for October -December 2011 was 3.3%.

3.2 二零一一年失業率的轉變是勞動人口和 就業人口變動的總結果。由於經濟表現改善 帶動勞工需求增加,就業人口在二零一一年 第四季上升至 3 618 900 的歷史高位。勞動人 口亦在二零一一年第四季上升至 3 734 900。 隨着人力平衡有所改善,經季節性調整的失 業率在二零一一年大部分時間呈現下降趨 勢,由二零一一年上半年的 3.5% - 3.6%下降 至二零一一年下半年的 3.2% - 3.3%。 (表一) 3.2 Changes in the unemployment rate in 2011 were the resultant effect of changes in labour force and employment. With the improved economic performance and resultant boost to the labour demand, the number of employed persons reached a record high of 3 618 900 in the fourth quarter (Q4) of 2011. The labour force also bounced up to 3 734 900 in the Q4 2011. Consequential to the improved manpower balance, the seasonally adjusted unemployment rate trended downward during most of 2011, declining from 3.5% – 3.6% in the first half of 2011 to 3.2% – 3.3% in the second half of 2011. ## **4.** 二零一一年按選定變數分析的失 業率的轉變

## 性別

4.1 男性的失業率(不經季節性調整)從二 零一一年第一季的 4.1%輕微上升至二零一一 年第二季的 4.4%, 然後逐步下降至二零一一 年第四季的 3.6%。同樣地,女性的失業率 (不經季節性調整)亦由二零一一年第一季 的 2.6%上升至二零一一年第二季及第三季的 3.0%, 然後下降至二零一一年第四季的 2.5%。 撇除外籍家庭傭工後,女性的失業率 (不經季節性調整)由二零一一年第一季的 3.0%上升至二零一一年第二季及第三季的 3.5%, 然後下降至二零一一年第四季的 3.0%。以二零一一年整體而言,女性在整體 失業人口中所佔的比例為 38.8%, 而男性及 女性的失業率分別爲 4.0%及 2.8% (撇除外籍 家庭傭工後的數字爲3.3%)。

# 4. Analysis of Changes in Unemployment Rate in 2011 by Selected Variables

#### Sex

The unemployment rate (not seasonally adjusted) for males increased slightly from 4.1% in the first quarter (Q1) of 2011 to 4.4% in the second quarter (Q2) of 2011 and then decreased progressively to 3.6% in Q4 2011. Likewise, the unemployment rate (not seasonally adjusted) for females increased from 2.6% in Q1 2011 to 3.0% in Q2 and third quarter (Q3) of 2011 and then decreased to 2.5% in Q4 2011. After excluding foreign domestic helpers, the unemployment rate (not seasonally adjusted) for females increased from 3.0% in Q1 2011 to 3.5% in Q2 and Q3 2011 and then fell to 3.0% in Q4 2011. For 2011 as a whole, the proportion of females in the total unemployed population was 38.8% and the unemployment rates for males and females were 4.0% and 2.8% (or 3.3% after excluding foreign domestic helpers) respectively. # 4.2 按年齡組別分析,除了 50 至 59 歲年齡組別外,所有年齡組別的失業率(不經季節性調整)在二零一一年下半年均呈現下降趨勢。 (表三)

## Age group

4.2 Analysed by age group, a declining trend in unemployment rate (not seasonally adjusted) was observed in the second half of 2011 for all age groups except for the age group of 50 to 59. (Table 3)

## 教育程度

4.3 具不同教育程度人士的失業率在二零一一年有不同的轉變。具初中、高中及專上教育(非學位)程度人士的失業率(不經季節性調整)在二零一一年第二季達至高位,隨後在最後兩季下降。另一方面,具專上教育(學位)程度人士的失業率(不經季節性調整)從二零一一年第一季及第二季的 2.3%上

## Educational attainment

4.3 The changes in the unemployment rate in 2011 varied for persons with different level of educational attainment. The unemployment rates (not seasonally adjusted) for persons with lower secondary, upper secondary and post-secondary non-degree education levels peaked in Q2 2011 and then decreased in the last two quarters. On the other hand, the unemployment rate for persons with post-secondary degree education level increased from

2.3% in Q1 and Q2 2011 to 2.5% in Q3 2011, and then decreased to 2.2% in Q4 2011. Both the number of unemployed persons and the corresponding unemployment rate (not seasonally adjusted) for persons with post-secondary education level showed an increase in Q3 2011 amidst the entry of fresh graduates and school leavers into the labour market. 4.4 在二零一一年下半年,大部分行業的失業率(不經季節性調整)均呈下降趨勢。下降最明顯的行業爲建造業,其失業率(不經季節性調整)從二零一一年第一季的 6.5%逐

## Previous industry

4.4 The unemployment rates (not seasonally adjusted) for most industry sectors exhibited a decreasing trend in the second half of 2011. The most notable decrease was found in the construction sector, with the unemployment rate (not seasonally

4.5 Decreases in unemployment rate (not seasonally adjusted) were observed in the second half of 2011 for lower-skilled occupations such as clerical support workers, service and sales workers and elementary occupations. (Table 6)

## 5. 概念及方法

- 5.1 *從事經濟活動人口*,即*勞動人口*,可分 爲就業人口及失業人口。勞動人口參與率是 指勞動人口在 15 歲及以上人口中所佔的比 例,用以量度適齡工作人士加入勞動人口的 傾向。
- 5.2 *非從事經濟活動人口*包括所有在統計 前七天內並無職位亦無工作的人士,在這七 天內正在休假的人士及失業人士除外。料理 家務者、退休人士及 15 歲以下的人士(例如 學生)等均包括在內。
- 5.3 *就業人口*包括所有在統計前七天內有做工賺取薪酬或利潤或有一份正式工作的 15歲及以上的人士。
- 5.4 *就業不足人口*包括在統計前七天內在 非自願情況下工作少於 35 小時,而在統計前 30 天內有找尋更多工作,或即使不是找尋工 作,但在統計前七天內可擔任更多工作的就 業人士。根據此定義,因工作量不足而在統 計前七天內放取無薪假期的就業人士,若在 該七天期間內工作少於 35 小時甚或全段期間 都在休假,亦會被界定爲就業不足人士。就 業不足人口爲就業人口的一部分。
- 5.5 *失業人口* 由所有失業人士構成。一名 15 歲或以上人士符合下列情況,便被界定爲 失業人士:
- (i) 在統計前七天內並無職位,且並無爲賺 取薪酬或利潤而工作;*及*
- (ii) 在統計前七天內隨時可工作; 及
- (iii) 在統計前 30 天內有找尋工作。

## 5. Concepts and Methods

- population, 5.1 The economically active synonymous with the labour force, comprises the employed population and the unemployed The labour force participation rate population. refers to the proportion of labour force in the population aged 15 and over. This is a measure of the propensity of persons of working age to be in the labour force.
- 5.2 The economically inactive population is made up of those persons who have not had a job and have not been at work during the seven days before enumeration, excluding persons who have been on leave/holiday during the seven-day period and persons who are unemployed. Persons such as home-makers, retired persons and those below the age of 15 (e.g. students) are thus included.
- 5.3 The *employed population* consists of those persons aged 15 and over who have been at work for pay or profit during the seven days before enumeration or have had formal job attachment.
- The underemployed population comprises those employed persons who have involuntarily worked less than 35 hours during the seven days before enumeration and have sought additional work during the 30 days before enumeration, or have not sought but have been available for additional work the seven days before enumeration. during Following this definition, employed persons taking no-pay leave due to slack work during the seven days enumeration are also classified underemployed if they worked less than 35 hours or were on leave even for the whole period during the seven-day period. The underemployed population is a part of the employed population.
- 5.5 The *unemployed population* comprises all unemployed persons. For a person aged 15 or over to be classified as unemployed, that person should:
- (i) not have had a job and should not have performed any work for pay or profit during the seven days before enumeration; *and*
- (ii) have been available for work during the seven days before enumeration; *and*
- (iii) have sought work during the 30 days before enumeration.

- 5.6 *失業率* 是指失業人士在勞動人口中所 佔的比例。計算方法是將失業人數除以勞動 人口數目,再乘以 100%。
- 5.7 有關各行業或各職業的失業率反映從事個別行業或職業的人士失業的嚴重程度。但是,在計算有關按行業或職業劃分的失業率時,要注意兩點: (i) 失業人士是按其以前從事的行業或職業劃分,該行業或職業跟他們日後將從事工作的行業或職業未必相同;及(ii) 沒有首次求職人士和重新加入勞動人口的失業人士以前從事行業或職業的資料。因此,按行業或職業劃分的失業率不能與整體失業率作嚴謹比較,同時亦須謹慎闡釋。
- 5.8 「綜合住戶統計調查」採用了結構完善的問卷以搜集所需的數據,從而客觀和準確 地界定被訪者的經濟活動身分。
- 5.9 有一點要留意,在「綜合住戶統計調查」中,並沒有使用如「家庭主婦」和「退休人士」之類的通稱。進行統計調查時,所用的問卷採用了一連串嚴謹而客觀的問題,以搜集所需的數據,從而界定一名受訪人士是否失業人士。一名人士若全時間在家中料理家務,則不包括在勞動人口中(即「非從事經濟活動」),亦不會被界定爲「就業」或「失業」。另一方面,若一名已婚的女士,身分雖然屬於一般所稱的「家庭主婦」,但隨時可工作及正積極地找尋工作,按照定義,她會被界定爲「失業人士」。
- 5.10 在非從事經濟活動人士中,有些人士若「遇上」對其有利的工作條件時(例如酬金

- However, if a person aged 15 or over fulfils the conditions (i) and (ii) above but has not sought work during the 30 days before enumeration because he believes that work is not available, he is still classified as unemployed, being regarded as a so-called "discouraged worker".
- 5.6 Unemployment rate refers to the proportion of unemployed persons in the labour force. It is computed by dividing the number of unemployed persons by the size of the labour force and multiplying the quotient by 100%.
- 5.7 The unemployment rates by industry or occupation reflect the degree of severity of unemployment in respect of persons engaged in individual industries or occupations. However, two points have to be noted in deriving the unemployment rates by industry or occupation: (i) unemployed persons are classified according to their previous industry or occupation which may not necessarily be the one which they will enter subsequently; and (ii) there is no information on previous industry or occupation in respect of first-time job-seekers and re-entrants into the labour force who are unemployed. Such rates are therefore not strictly comparable to the overall unemployment rate and should be interpreted with caution.
- 5.8 A well-structured questionnaire is adopted in the GHS to collect the required data for classifying the economic activity status of the respondents objectively and accurately.
- It should be noted that generic terms like "housewife" and "retired person" are not used in the GHS. In conducting the survey, the questionnaire adopted contains a series of rigorous and objective questions in order to collect the required data for classifying whether a person being enquired is unemployed or not. If a person is engaged in household work on a full time basis at home, this person is outside the labour force (i.e. being "economically inactive") and he will not be classified as "employed" or "unemployed". On the other hand, if a married female regards herself as the socalled "housewife" but is available for work and is actively seeking work, she is classified "unemployed" in accordance with the definition.
- 5.10 There are also cases that among the economically inactive persons, some might consider

- 5.11 有一點亦要留意,「失業」 所指的是一種狀態,而並非「失去工作」的事件(例如遭解僱或遣散,或因其他理由而離職)。故此,一些被解僱或因其他理由離職的人士,若在很短期間內已轉爲從事另一份工作,雖然他們在有關期間內曾經歷「失去工作」的事件,但根據定義,他們在統計時並不算在失業人口內。
- 5.12 由於失業率受季節性變異(包括首次求職人士所導致的季節性差異、假期影響及業務的季節性起伏)的影響,故政府統計處公布失業率時已作出季節性調整。經季節性調整的失業率,更能確切反映失業的趨勢,以便比較不同時間的失業率。在本文中,載列於第三節的整體失業率已經季節性調整,而載列於第四節的按選定變數分析的失業率,由於數據的局限,則沒有經季節性調整。
- 5.13 有關「綜合住戶統計調查」所涉及的資料項目及其相關的概念和定義的詳細資料, 刊載於《綜合住戶統計調查按季統計報告》 內。

- entering the labour force only if they "encounter" jobs with terms favourable to their own situations (e.g. remuneration meeting their own expectation. working hours with adequate flexibility or workplace near home). However, their specific wishes may not be commensurate with prevailing local conditions in the labour market. According to international standard, such persons should still be classified as economically inactive, despite the fact that they have some desire for work. Although such persons do not form part of the unemployed population, statistics on them are useful information in their own right. In the case of Hong Kong, some relevant statistics are available in the Census and Statistics Department (C&SD). Reference could be made to the Special Topics Reports No. 31, No. 41, No. 51 and No. 59 on the topic "Desire of economically inactive persons for taking up jobs if being offered suitable employment" published by the C&SD.
- 5.11 It should also be noted that "unemployment" refers to a state of affairs, but not the events of "losing a job" like dismissal or lay-off or having left a job for other reasons. Thus, for persons who have been dismissed from their jobs or who have left their jobs for certain reasons, but have managed to take up another job within a short period of time, they should not be counted in the unemployed population by definition at the time of enumeration, even though they have experienced the event of "losing a job" during the period concerned.
- 5.12 As unemployment rate is subject to seasonal variations (such as seasonal variations in the number of first-time job-seekers, holiday effects and seasonal ups and downs in business activities), seasonal adjustment has been made when the unemployment rate is released. The seasonally adjusted unemployment rate so compiled can better reflect the underlying trend of unemployment and facilitate the comparison of unemployment rates over time. this article, seasonal adjustment has been applied to the overall unemployment rates presented in Section 3, while those unemployment rates analysed by selected variables as presented in Section 4 are not seasonally adjusted because of data limitation.
- 5.13 Details about the data items included in the GHS and their corresponding concepts and definitions are given in the *Quarterly Report on General Household Survey*.
