# 二零零三年失業率的走勢 The Movement of the Unemployment Rate in 2003

經季節性調整的失業率從二零零二年第四季的 7.2%上升至二零零三年五月至七月期間的 8.7%,這主要是由於在二零零三年三月爆發的嚴重急性呼吸系統綜合症對香港經濟所造成的負面影響所致。隨着嚴重急性呼吸系統綜合症自二零零三年六月大致受到控制,以及在二零零三年後期訪港旅遊業及本地消費復蘇的情況下,經季節性調整的失業率逐步回落至二零零三年第四季的 7.3%。本文旨在對二零零三年的失業率的轉變作多方面分析,從而令讀者對香港近期的失業情況有更清楚的了解。

The seasonally adjusted unemployment rate increased from 7.2% in the fourth quarter of 2002 to 8.7% in May-July 2003. This was mainly attributed to the adverse impact on the Hong Kong economy brought about by the outbreak of the Severe Acute Respiratory Syndrome (SARS) in March 2003. ## 二零零三年失業率的走勢

### The Movement of the Unemployment Rate in 2003

#### 1. 引言

- 1.1 經季節性調整的失業率從二零零二年第四季的 7.2%上升至二零零三年五月至七月期間的 8.7%,這主要是由於在二零零三年三月爆發的嚴重急性呼吸系統綜合症對香港經濟所造成的負面影響所致。隨着嚴重急性呼吸系統綜合症自二零零三年次月大致受到控制,以及在二零零三年後期訪港旅遊業及本地消費復蘇的情況下,經季節性調整的失業率逐步回落至二零零三年第四季的 7.3%。
- 1.2 失業是社會關注的焦點之一。有關失業的統計量數對經濟情況提供一個指標,亦反映 勞動力剩餘的程度。
- 1.3 有關失業的統計數字是根據綜合住戶統計調查獲取的數據而編製。綜合住戶統計調查每三個月期間的樣本規模約為 24 000 個住戶。在選中的住戶內,所有有關人士均被問及關於個人、勞動力和住戶特徵的資料。
- 1.4 本文旨在對二零零三年的失業率的轉變 作多方面分析,從而令讀者對香港近期的失業 情況有更清楚的了解。

#### 2. 概念架構

2.1 有關勞動人口、就業、失業及就業不足等的統計數字,均是按照國際勞工組織建議的概念架構編製。該組織所訂定有關定義及其他相關事宜的建議,都是經過不少經濟、社會及統計學家和統計工作者作出研究和深入討論而得出的結果,自有其一定的合理性。而採用國際認同的定義編製的統計數字,才可作國際間的比較。

#### 1. Introduction

- 1.1 The seasonally adjusted unemployment rate increased from 7.2% in the fourth quarter (Q4) of 2002 to 8.7% in May-July 2003. This was mainly attributed to the adverse impact on the Hong Kong economy brought about by the outbreak of the Severe Acute Respiratory Syndrome (SARS) in March 2003. With the SARS largely under control since June 2003, and the rebounds in inbound tourism and local consumer spending in the latter part of 2003, the seasonally adjusted unemployment rate progressively fell to 7.3% in Q4 2003.
- 1.2 Unemployment is one of the focal issues of social concern. Statistical measures of unemployment provide an indication of the situation of the economy and also reflect the extent of unused capacity in the labour force.
- 1.3 Unemployment statistics are compiled based on data obtained from the General Household Survey (GHS). The sample size of the GHS is about 24 000 households in each three-month period. Information on personal, labour force and household characteristics is collected from all persons in the sampled households where appropriate.
- 1.4 This article provides an analysis of the changes in the unemployment rate in 2003 from various perspectives. It aims to give a better understanding about the recent unemployment situation in Hong Kong.

#### 2. Conceptual Framework

Statistics on the labour force, employment, unemployment and underemployment are compiled in accordance with the conceptual framework recommended by International Labour the Organization (ILO). The recommendations regarding definitions and other related issues have been based on research and in-depth discussions among economists, sociologists, statisticians and statistical practitioners concerned, and are highly rational. Moreover, only statistics based on internationally accepted definitions are internationally comparable.

- 2.2 人口中的個別人士可按其經濟活動身分 劃分爲從事經濟活動人口及非從事經濟活動人 口兩大類。
- 2.3 *從事經濟活動人口*,即*勞動人口*,可分爲 就業人口及失業人口。勞動人口參與率是指勞 動人口在十五歲及以上人口中所佔的比例,用 以量度適齡工作人士加入勞動人口的傾向。
- 2.4 *非從事經濟活動人口*包括所有在統計前 七天內並無職位亦無工作的人士,在這七天內 正在休假的人士及失業人士除外。料理家務 者、退休人士及十五歲以下的人士(例如學生) 等均包括在內。
- 2.5 *就業人口*包括所有在統計前七天內有做工賺取薪酬或利潤或有一份正式工作的十五歲及以上的人士。
- 2.6 *就業不足人口*包括在統計前七天內在非自願情況下工作少於三十五小時,而在統計前三十天內有找尋更多工作,或即使不是找尋工作,但在統計前七天內可擔任更多工作的就業人士。根據此定義,因工作量不足而在統計前七天內放取無薪假期的就業人士,若在該七天期間內工作少於三十五小時甚或全段期間都在休假,亦會界定爲就業不足人士。就業不足人口爲就業人口的一部分。
- 2.7 *失業人口*由所有失業人士構成。一名十五 歲或以上人士符合下列情況,便界定爲失業人 士:
  - (a) 在統計前七天內並無職位,且並無爲 賺取薪酬或利潤而工作; **及**
  - (b) 在統計前七天內隨時可工作; 及
  - (c) 在統計前三十天內有找尋工作。

- 2.2 Individuals in the population can be divided into two main groups according to their economic activity status, viz. the economically active population and the economically inactive population.
- 2.3 The *economically active population*, synonymous with the *labour force*, comprises the employed population and the unemployed population. The labour force participation rate refers to the proportion of labour force in the population aged 15 and over. This is a measure of the propensity of persons of working age to be in the labour force.
- 2.4 The *economically inactive population* is made up of those persons who have not had a job and have not been at work during the seven days before enumeration, excluding persons who have been on leave/holiday during the seven-day period and persons who are unemployed. Persons such as home-makers, retired persons and those below the age of 15 (e.g. students) are thus included.
- 2.5 The *employed population* consists of those persons aged 15 and over who have been at work for pay or profit during the seven days before enumeration or have had formal job attachment.
- 2.6 The *underemployed population* comprises those employed persons who have involuntarily worked less than 35 hours during the seven days before enumeration and have sought additional work during the thirty days before enumeration, or have not sought but have been available for additional work during the seven days before enumeration. Following this definition, employed persons taking no-pay leave due to slack work during the seven days before enumeration are also classified as underemployed if they worked less than 35 hours or were on leave even for the whole period during the seven-day period. The underemployed population is a part of the employed population.
- 2.7 The *unemployed population* comprises all unemployed persons. For a person aged 15 or over to be classified as unemployed, that person should:
  - (a) not have had a job and should not have performed any work for pay or profit during the seven days before enumeration; *and*
  - (b) have been available for work during the seven days before enumeration; *and*
  - (c) have sought work during the thirty days before enumeration.

- 不過,一名十五歲或以上的人士,如果他/她符合上述(a)和(b)的條件,但沒有在統計前三十天內找尋工作的原因爲相信沒有工作可做,則仍會被界定爲失業,即所謂「因灰心而不求職的人士」。
- 2.8 *失業率*是指失業人士在勞動人口中所佔的比例。計算方法是將失業人數除以勞動人口數目,再乘以 100%。
- 2.9 綜合住戶統計調查採用了結構完善的問 卷以搜集所需的數據,從而客觀和準確地界定 被訪者的經濟活動身分。
- 2.10 有一點要留意,在綜合住戶統計調查中,並沒有使用如「家庭主婦」和「退休人士」之類的通稱。進行統計調查時,所用的問卷採用了一連串嚴謹而客觀的問題,以搜集所需的數據,從而界定一名受訪人士是否失業人士。一名人士若全時間在家中料理家務,則不包括在勞動人口中(即「非從事經濟活動」),亦不會被界定爲「就業」或「失業」。另一方面,若一名已婚的女士,身分雖然屬於一般所稱的「家庭主婦」,但隨時可工作及正積極地找尋工作,按照定義,她會被界定爲「失業人士」。
- 2.11 在非從事經濟活動人士中,有些人士若「遇上」對其有利的工作條件時(例如酬金符合他們的期望、工作時間有足夠彈性或工作地點接近居所),才會考慮投入勞動人口。但是,他們個別的意願未必符合本地勞工市場的一般情況。根據國際標準,雖然他們有工作意欲,但仍應界定爲非從事經濟活動人士。然而,這些人士雖不屬失業人口的一部分,但是有關這些人士的統計數字仍是有用的統計資料。以香港而言,政府統計處可提供一些關於這方面的統計數字。(備註:讀者可參考本處出版的第十四號、第十九號、第二十六號及第三十一號社會統計專題報告書。)

- However, if a person aged 15 or over fulfils the conditions (a) and (b) above but has not sought work during the thirty days before enumeration because he/she believes that work is not available, he/she is still classified as unemployed, being regarded as a so-called "discouraged worker".
- 2.8 Unemployment rate refers to the proportion of unemployed persons in the labour force. It is computed by dividing the number of unemployed persons by the size of the labour force and multiplying the quotient by 100%.
- 2.9 A well-structured questionnaire is adopted in the GHS to collect the required data for classifying the economic activity status of the respondents objectively and accurately.
- 2.10 It should be noted that generic terms like "housewife" and "retired person" are not used in the GHS. In conducting the survey, the questionnaire adopted contains a series of rigorous and objective questions in order to collect the required data for classifying whether a person being enquired is unemployed or not. If a person is engaged in household work on a full time basis at home, this person is outside the labour force (i.e. being "economically inactive") and he/she will not be classified as "employed" or "unemployed". On the other hand, if a married female regards herself as the so-called "housewife" but is available for work and is actively seeking work, she is classified as "unemployed" in accordance with the definition.
- 2.11 There are also cases that among the economically inactive persons, some might consider entering the labour force only if they "encounter" jobs with terms favourable to their own situations (e.g. remuneration meeting their own expectation, working hours with adequate flexibility or workplace near home). However, their specific wishes may not be commensurate with prevailing local conditions in the labour market. According to international standard, such persons should still be classified as economically inactive, despite the fact that they have some desire for work. Although such persons do not form part of the unemployed population, statistics on them are useful information in their own right. In the case of Hong Kong, some relevant statistics are available in the Census and Statistics Department. Reference could be made to the Special Topics Report No. 14, No. 19, No. 26 and No. 31 published by the department.)

- 2.12 有一點亦要留意,「失業」 所指的是一種狀態,而並非「失去職業」的事件(例如遭解僱或遣散,或因其他理由而離職)。故此,一些被解僱或因其他理由離職的人士,若在很短期間內已轉爲從事另一份工作,雖然他們在有關期間內曾經歷「失去職業」的事件,但根據定義,他們在統計時並不算在失業人口內。
- 2.13 由於失業率受季節性變異(包括首次求職人士所導致的季節性差異、假期影響及業務的季節性起伏)的影響,故政府統計處已採用「X-11 自迴歸-求和-移動平均」方法就其季節性變異作出調整。經季節性調整的失業率,更能確切反映失業的趨勢,以便對失業率作不同時間的比較。在本文中,載列於第三節的整體失業率已經季節性調整,而載列於第四節的按選定特徵分析的失業率,由於數據的局限,則是不經季節性調整。
- 2.14 有關綜合住戶統計調查所涉及的資料項目及其相關的概念和定義的更詳細資料,刊載於「綜合住戶統計調查按季統計報告書」。

#### 3. 整體失業率的變動趨勢

- 3.1 一九九七年後期,香港經濟向下調整, 失業率由九七年的 2.2%急升至九八年的 4.7% 及九九年的 6.2%。隨着香港經濟於九九年後期 復蘇,香港的勞工市場在二零零零年顯著改 善,失業率下降至 4.9%。然而,由於二零零一 年上半年外圍經濟放緩,失業率在二零零一年 轉趨上升,並升至 5.1%。在勞工市場進一步放 緩的情況下,失業率隨後更顯著上升至二零零 二年的 7.3%及二零零三年的 7.9%。
- 3.2 二零零三年失業率的轉變是勞動人口增 長和就業人口增長的總結果。由於二零零三年

- 2.12 It should also be noted that "unemployment" refers to a state of affairs, but not the events of "losing a job" like dismissal or lay-off or having left a job for other reasons. Thus, for persons who have been dismissed from their jobs or who have left their jobs for certain reasons, but have managed to take up another job within a short period of time, they should not be counted in the unemployed population by definition at the time of enumeration, even though they have experienced the event of "losing a job" during the period concerned.
- 2.13 As unemployment rate is subject to seasonal variations (such as seasonal variations in the number of first-time job-seekers, holiday effects and seasonal ups and downs in business activities), the Census and Statistics Department has adopted the X-11 ARIMA method to seasonally adjust the unemployment rate. The seasonally adjusted unemployment rate so compiled can better reflect the underlying trend of unemployment and facilitate the comparison of unemployment rates over time. In this article, seasonal adjustment has been applied to the overall unemployment rates presented in Section 3, while those unemployment rates analysed by selected characteristics as presented in Section 4 are not seasonally adjusted because of data limitation.
- 2.14 Greater details on the GHS data items and their corresponding concepts and definitions are given in the "Quarterly Report on General Household Survey".

## 3. Trend of Changes in the Overall Unemployment Rate

- 3.1 In late 1997, the Hong Kong economy experienced a downward adjustment. The unemployment rate increased sharply from 2.2% in 1997 to 4.7% in 1998 and further to 6.2% in 1999. Following the economic recovery in late 1999, the labour market of Hong Kong improved significantly in 2000. The unemployment rate dropped to 4.9%. However, the unemployment rate reversed to a rising trend with the slow-down in external economy in the first half of 2001, and reached 5.1% in 2001. As the labour market further slackened, the unemployment rate then increased significantly to 7.3% in 2002 and 7.9% in 2003 respectively.
- 3.2 Changes in the unemployment rate in 2003 were the resultant effect of labour force growth and employment growth. Owing to the increase in the

上半年勞動人口增加及自二零零三年三月嚴重 急性呼吸系統綜合症爆發對就業情況造成負面 影響,經季節性調整的失業率由二零零三年第 一季的 7.5%大幅上升至二零零三年五月至七 月的 8.7%。在二零零三年下半年勞動人口轉爲 下降,以及在二零零三年後期整體就業人數在 訪港旅遊業及本地消費復蘇的帶動下大幅回 升,因此經季節性調整的失業率由二零零三年 六月至八月開始下降,並逐步回落至二零零三 年第四季的 7.3%。(表一) size of labour force in the early half of 2003 and the adverse impact on employment brought about by the SARS outbreak since March 2003, the seasonally adjusted unemployment rate increased substantially from 7.5% in Q1 2003 to 8.7% in May-July 2003. The labour force reversed to a declining trend in the second half of 2003, while total employment picked up drastically towards the end of 2003 consequential to the rebounds in inbound tourism and local consumer spending. As a result, the seasonally adjusted unemployment rate began to decrease in June-August 2003 and progressively fell to 7.3% in Q4 2003. (Table 1)

#### 4. 二零零三年的失業率轉變的分析

#### 性別

4.1 二零零三年男性及女性的失業率(不經季節性調整)轉變的趨勢大致相同。然而,男性的失業率由二零零三年第一季的 8.7%下降至二零零三年第四季的 8.4%,在同期間,女性的失業率則維持在 5.8%,兩性間的失業率差距因而收窄。而女性在整體失業人口所佔的比例,在同期間亦由 34.3%上升至 35.3%,在二零零三年,男性及女性的平均失業率分別爲 9.3%及 6.2%。 (表二)

## 4. Analysis of Changes in the Unemployment Rate in 2003

Sex

4.1 The changes in the unemployment rates (not seasonally adjusted) for males and females followed a broadly similar trend. However, the unemployment rate for males decreased from 8.7% in Q1 2003 to 8.4% in Q4 2003 while that for females remained unchanged at 5.8% over the same period. In consequence, the difference in unemployment rate between the two sexes narrowed. The proportion of females in the total unemployed population also increased from 34.3% to 35.3% over the same period. In 2003, the average unemployment rate for males and females were 9.3% and 6.2% respectively. (Table 2)

## 年齡組別

4.2 按年齡分析,在二零零三年,十五至十 九歲及五十至五十九歲年齡組別人士受失業的 影響似乎最大。十五至十九歲年齡組別人士的 失業率(不經季節性調整)因新一批離校人士及 畢業生在暑假後期進入勞工市場,在二零零三 年第三季升至 36.1%的高水平。可能由於這兩 個年齡組別的人士的工作技能較低,所以當勞 工市場放緩時,他們較難找到工作。此外,在 二零零三年第四季,五十至五十九歲及六十歲 及以上年齡組別人士的失業率仍較二零零三年 第二季的為高,反映這些年齡組別人士所面對 的失業問題,並沒有因二零零三年後期整體失 業情況的改善而得到紓緩。(表三)

#### Age Group

Analysed by age, persons in the 15-19 age group and the 50-59 age group seemed to be hardest hit by unemployment in 2003. The unemployment rate (not seasonally adjusted) for the former surged to 36.1% in Q3 2003 as the new batch of school leavers and fresh graduates entered the labour market in the late summer Apparently, the persons in these two age groups had greater difficulty in finding jobs under the slack labour market conditions, probably on account of their limited work skills. Besides, the unemployment rates for persons in the 50-59 age group and the 60 and over age group were higher in Q4 2003 as compared to Q2 2003, reflecting that the unemployment problem for persons in these age groups did not ease off despite the improvement in the overall unemployment situation towards the end of the year. #### 教育程度

Overall

4.3 在二零零三年第一季及二零零三年第二季期間,具小學教育程度人士的失業率(不經季節性調整)的升幅最大。就未受教育/具幼稚園教育程度的人士而言,雖然整體失業情況在二零零三年後期有所改善,這些人士的失業情況仍未見好轉,其失業率由二零零三年第一季的10.2% 明顯上升至二零零三年第四季的12.3%。這些數字顯示具較低教育程度人士在失業情況轉差時一般較受影響,這情況可能是由於香港在經濟轉型下對非技術工人的需求下降所致。(表四)

#### **Educational Attainment**

4.3 unemployment rate (not seasonally adjusted) for those persons with primary education showed the largest increase between Q1 2003 and Q2 For persons with no schooling/kindergarten education, their unemployment situation worsened despite the improvement in the overall unemployment situation towards the end of 2003. unemployment rate increased distinctly from 10.2% in Q1 2003 to 12.3% in Q4 2003. These figures indicated that persons with lower education attainment were generally more vulnerable at times of rising unemployment, probably attributed to the diminishing demand for unskilled workers in the labour market amidst the restructuring of the Hong Kong economy. 4.4 有關各行業的失業率(不經季節性調整) 反映從事個別行業人士失業的嚴重程度。但是,在計算有關按行業劃分的失業率的分子和分母時,要注意兩點:(i)失業人士是按其以前從事的行業劃分,該行業跟他們日後將從事工作的行業未必相同;及(ii)沒有首次求職人士和重新加入勞動人口的失業人士以前從事行業的資料。因此,按行業劃分的失業率不能與整體失業率作嚴謹比較,同時亦須謹慎闡釋。上述詮釋亦適用於下文有關「以前從事的職業」的分析(第 4.6 段)。

#### **Previous Industry**

4.4 The unemployment rates (not seasonally adjusted) by industry reflect the degree of severity of unemployment in respect of persons engaged in individual industries. However, two points have to be noted in deriving both the numerator and the denominator regarding unemployment rates by industry: (i) unemployed persons are classified according to their previous industry which may not necessarily be the one which they will enter subsequently; and (ii) there is no information on previous industry in respect of first-time job-seekers and re-entrants into the labour force who are unemployed. Such rates are therefore not strictly comparable to the overall unemployment rate and should be interpreted with caution. These remarks are also applicable to the analysis on "previous occupation" below (paragraph 4.6).

4.5 在二零零三年,以前從事建造業的失業 人士有最高的平均失業率(19.0%)。然而,這些 人士在二零零三年第四季的失業率(不經季節 性調整)(17.7%)已低於二零零三年第一季 (18.9%)的水平,顯示建造業的失業情況在二零 零三年後期已有改善。此外,在外貿表現強勁 及訪港旅遊業和本地消費復蘇的情況下,以前 從事批發、零售、進出口貿易、飲食及酒店業 的失業人數及失業率,在二零零三年第四季相 對於二零零三年第一季期間,亦明顯下降。(表 五)

Unemployed persons with a previous job in the construction sector had the highest average unemployment rate (19.0%) in 2003. Nevertheless, the unemployment rate (not seasonally adjusted) for these persons was lower in Q4 2003 (17.7%) as compared with Q1 2003 (18.9%), indicating some improvement in the unemployment situation in the construction sector towards the end of 2003. Besides, the number of unemployed persons with a wholesale, retail and previous job in the import/export trades, restaurants and hotels sector and the corresponding unemployment rate also showed a noticeable decrease in Q4 2003 as compared with Q1 2003, amidst the strong performance in external trade and the rebounds in inbound tourism and local consumer spending. #### 以前從事的職業

4.6 在二零零三年第一季至第三季期間,以前曾任職經理及行政級人員的失業人數和失業率(不經季節性調整),大致保持穩定,但在二零零三年第四季則明顯上升。相反,以前從事其他職業組別(如專業人員、輔助專業人員等)的失業人數和失業率,在二零零三年第二季因受嚴重急性呼吸系統綜合症爆發的負面影響而急升後,在二零零三年後期一般均見下降,尤其是以前從事服務工作及商店銷售人員的失業人數有較大的跌幅。(表六)

#### **Previous Occupation**

4.6 The number of unemployed persons and the corresponding unemployment rate (not seasonally adjusted) for those who previously worked as managers and administrators remained stable during Q1 2003 to Q3 2003, but increased distinctly in Q4 2003. In contrast, unemployed persons who previously worked in other occupation categories (such as professionals, associate professionals, etc.) generally showed some decreases towards the end of 2003, after the rapid increases in Q2 2003 amidst the adverse impact of the SARS outbreak, particularly for those who previously worked as service workers and shop sales workers.
