The unemployment rate began to move up in the second half of 2008, alongside the slowdown in business activities in both the domestic and external trade sectors due to the global financial tsunami. The seasonally adjusted unemployment rate climbed to 5.4% in April – June 2009. The Hong Kong economy exhibited much resilience in countering the global financial tsunami and the ensuing global recession, with the seasonally adjusted unemployment rate began to show signs of improvement starting from the second half of 2009 and decreased to 4.9% in October – December 2009. This article provides an analysis of the changes in the unemployment rate in 2009 from various perspectives. It aims to give readers a better understanding about the recent unemployment situation in Hong Kong.

The Movement of the Unemployment Rate in 2009

1. 引言

- 1.1 隨着本地經濟及對外貿易行業的商業活動受環球金融海嘯的影響而減慢,經季節性調整的失業率在二零零八年下半年開始回升,並在二零零九年四月至六月上升至 5.4%。香港經濟在抵禦全球金融海嘯及隨後的全球經濟衰退方面,展現了相當韌力,經季節性調整的失業率自二零零九年下半年開始逐步改善,並下跌至二零零九年十月至十二月的 4.9%。
- 1.2 失業是社會關注的焦點之一。有關失業的統計量數對經濟情況提供一個指標,亦反映勞動力剩餘的程度。
- 1.3 有關失業的統計數字是根據「綜合住戶統計調查」獲取的數據而編製。「綜合住戶統計調查」每三個月期間的樣本規模約為 24 000 個住戶。在選中的住戶內,所有有關人士均被問及關於個人、勞動力和住戶特徵的資料。
- 1.4 本文旨在對二零零九年的失業率的轉變 作多方面分析,從而令讀者對香港近期的失業 情況有更清楚的了解。

2. 概念架構

2.1 有關勞動人口、就業、失業及就業不足等的統計數字,均是按照國際勞工組織建議的概念架構編製。該組織所訂定有關定義及其他相關事宜的建議,都是經過不少經濟、社會及統計學家和統計工作者作出研究和深入討論而得出的結果,自有其一定的合理性。而採用國際認同的定義編製的統計數字,才可作國際間的比較。

1. Introduction

- The unemployment rate began to move up in the second half of 2008, alongside the slowdown in business activities in both the domestic and external trade sectors due to the global financial tsunami. The seasonally adjusted unemployment rate climbed to 5.4% in April – June 2009. The Hong Kong economy exhibited much resilience in countering the global financial tsunami and the ensuing global recession, with the seasonally adjusted unemployment rate began to show signs of improvement in the second half of 2009 and decreased to 4.9% in October – December 2009.
- 1.2 Unemployment is one of the focal issues of social concern. Statistical measures of unemployment provide an indication of the economic situation and also reflect the extent of unused capacity in the labour force.
- 1.3 Unemployment statistics are compiled based on data obtained from the General Household Survey (GHS). The sample size of the GHS is about 24 000 households in each three-month period. Information on personal, labour force and household characteristics is collected from all persons in the sampled households where appropriate.
- 1.4 This article provides an analysis of the changes in the unemployment rate in 2009 from various perspectives. It aims to give readers a better understanding about the recent unemployment situation in Hong Kong.

2. Conceptual Framework

Statistics on the labour force, employment, 2.1 unemployment and underemployment are compiled in accordance with the conceptual framework recommended by the International Organization. The recommendations regarding definitions and other related issues have been based on research and in-depth discussions among economists, sociologists, statisticians and statistical practitioners concerned, and are highly rational. Moreover, only statistics based on internationally accepted definitions are internationally comparable.

3. 失業率近年變動的趨勢

- 3 1 由於嚴重急性呼吸系統綜合症在二零零 三年三月至六月期間爆發,經季節性調整的失 業率在二零零三年四月至六月上升至 8.5%的 歷史性高位。勞工市場於二零零三年下半年開 始顯著改善,而經季節性調整的失業率則持續 下跌,並於二零零八年五月至七月跌至3.2%, 是自一九九八年年初以來的最低位。隨着本地 經濟及對外貿易行業的商業活動受環球金融 海嘯的影響而減慢,經季節性調整的失業率在 二零零八年下半年開始回升,並在二零零九年 四月至六月上升至5.4%。香港經濟在抵禦全球 金融海嘯及隨後的全球經濟衰退方面,展現了 相當韌力,經季節性調整的失業率自二零零九 年下半年開始逐步改善,並下跌至二零零九年 十月至十二月的 4.9%。
- 3.2 二零零九年失業率的轉變是勞動人口和 就業人口變動的總結果。勞動人口及就業人口 在二零零九年大致保持平穩。雖然經季節性調 整的失業率在二零零九年上半年呈現上升趨 勢,至二零零九年第二季的 5.4%,但在二零零 九年下半年,經季節性調整的失業率呈現下跌 趨勢,至二零零九年第四季的 4.9%。 (表一)

2.2 Individuals in the population can be divided into two main groups according to their economic activity status, viz. the economically active population and the economically inactive population. For details on the concepts and definitions, please see Section 5 of this article.

3. Trend of Changes in the Unemployment Rate in Recent Years

- As a result of the outbreak of the Severe Acute Respiratory Syndrome during March to June in 2003, the seasonally adjusted unemployment rate rose to the historical high of 8.5% in April – June 2003. The labour market showed distinct improvement as from the latter half of 2003 and the seasonally adjusted unemployment rate continued to decrease and reached 3.2% in May – July 2008, the lowest level since early 1998. The unemployment rate began to move up in the second half of 2008, alongside the slowdown in business activities in both the domestic and external trade sectors due to the global financial The seasonally adjusted unemployment rate climbed to 5.4% in April – June 2009. The Hong Kong economy exhibited much resilience in countering the global financial tsunami and the ensuing global recession, with the seasonally adjusted unemployment rate began to show signs of improvement in the second half of 2009 and decreased to 4.9% in October – December 2009.
- 3.2 Changes in the unemployment rate in 2009 were the resultant effect of changes in labour force and employment. Both labour force and the number of employed persons were relatively stable in 2009. While the seasonally adjusted unemployment rate exhibited an increasing trend in the first half of 2009 to 5.4% in Q2 2009, the seasonally adjusted unemployment rate decreased in the second half of 2009, to 4.9% in Q4 2009. 4. 二零零九年按選定變數分析的失業 率的轉變

性別

4.1 整體上,男性及女性的失業率(不經季節性調整)在二零零九年首三季均呈上升趨勢,而在第四季則下跌。男性的失業率(不經季節性調整)從二零零九年第一季的 6.0%上升至二零零九年第二及第三季的 6.4%,然後下跌至二零零九年第四季的 5.5%。女性的失業率(不經季節性調整)亦由二零零九年第一季的 4.0%上升至二零零九年第三季的 4.8%,然後下跌至二零零九年第四季的 3.9%。在二零零九年,女性在整體失業人口中所佔的比例 爲 38.3%,而男性及女性的失業率分別爲 6.2% 及 4.4%。(表二)

4. Analysis of Changes in the Unemployment Rate in 2009 by Selected Variables

Sex

4.1 In general, both males and females showed increases in unemployment rate (not seasonally adjusted) in the first three quarters of 2009 but decreases in the last quarter of 2009. unemployment rate (not seasonally adjusted) for males increased from 6.0% in Q1 2009 to 6.4% in the second and third quarters of 2009 and then decreased to 5.5% in Q4 2009. The unemployment rate (not seasonally adjusted) for females increased from 4.0% in Q1 2009 to 4.8% in Q3 2009 and then decreased to 3.9% in Q4 2009. In 2009, the proportion of females in the total unemployed population was 38.3% and the unemployment rates for males and females were 6.2% and 4.4% respectively. (Table 2)

年齡組別

4.2 除了六十歲及以上的年齡組別外,差不多所有年齡組別人士的失業率(不經季節性調整)在二零零九年首兩至三季均呈上升趨勢,其後在第四季下跌。失業率(不經季節性調整)的升幅在十五至十九歲年齡組別人士中最爲明顯,由二零零九年第一季的 16.6%上升至二零零九年第三季的 25.7%,然後回落至二零零九年第四季的 20.1%。 (表三)

Age group

4.2 In 2009, an increasing trend in unemployment rate (not seasonally adjusted) was observed in the first two to three quarters and the rate fell in the last quarter in virtually all age groups, except for the age group of 60 and over. The increase in unemployment rate (not seasonally adjusted) was most significant for persons aged 15–19, rose from 16.6% in Q1 2009 to 25.7% in Q3 2009 and then decreased to 20.1% in Q4 2009. 教育程度

4.3 具不同教育程度人士的失業率在二零零九年有不同的轉變。具小學及以下教育程度人士的失業率(不經季節性調整)在二零零九年有下跌趨勢。另一方面,具專上教育程度人士的失業率(不經季節性調整)從二零零九年第一季的 3.6%上升至二零零九年第三季的 4.9%,然後下跌至二零零九年第四季的 4.0%。具專上教育程度人士(包括非學位及學位)的失業人數及其失業率(不經季節性調整)在二零零九年第三季均顯著上升,這是因爲新一批畢業生及離校人士進入勞工市場。 (表四)

Educational attainment

The changes in the unemployment rate in 2009 varied for persons with different level of educational attainment. The unemployment rate (not seasonally adjusted) for persons with primary education and below showed a decreasing trend in 2009. On the other hand, the unemployment rate for persons with post-secondary educational attainment increased from 3.6% in Q1 2009 to 4.9% in Q3 2009, and then decreased to 4.0% in Q4 2009. Both the number of unemployed persons and the corresponding unemployment rate (not seasonally adjusted) for persons with post-secondary education level (both non-degree and degree) showed a significant increase in Q3 2009 amidst the entry of fresh graduates and school leavers into the labour market. 以前從事的行業

4.4 在二零零九年上半年,大部分行業的失業率(不經季節性調整)均呈上升趨勢,而在在二零零九年下半年則下跌。在二零零九年上半年上升較明顯的行業爲建造業。這行業的失業率(不經季節性調整)從二零零八年第四季的6.1%上升5.7個百分點至二零零九年第二季的11.8%。另一方面,運輸、倉庫、郵政及速遞服務、資訊及通訊業的失業率(不經季節性調整)在二零零九年持續下跌。(表五)

Previous industry

4.4 The unemployment rates (not seasonally adjusted) for most industry sectors increased in the early part of 2009 and then decreased in the latter part of 2009. The most notable increase in unemployment in the first half of 2009 was found in the construction sector. The unemployment rates (not seasonally adjusted) of this industry sector increased by 5.7 percentage points from 6.1% in Q4 2008 to 11.8% in Q2 2009. On the other hand, the unemployment rate (not seasonally adjusted) of the transportation, storage, postal and courier services, information and communications sector decreased throughout 2009. 以前從事的職業

4.5 在二零零九年上半年,專業人員、輔助專業人員、文員、服務工作及商店銷售人員和工藝及有關人員的失業率(不經季節性調整)均上升。在二零零九年第四季,除了專業人員外,其他職業階層的失業率(不經季節性調整)均下跌。(表六)

Previous occupation

4.5 Increases in unemployment rate (not seasonally adjusted) were observed for professionals, associate professionals, clerks, service workers and shop sales workers, and craft and related workers in the first half of 2009. Declines in unemployment rate (not seasonally adjusted) were observed for most occupation groups, except professionals, in the fourth quarter of 2009. (Table 6)

5. 概念及方法

- 5.1 *從事經濟活動人口*,即*勞動人口*,可分 爲就業人口及失業人口。勞動人口參與率是指 勞動人口在十五歲及以上人口中所佔的比 例,用以量度適齡工作人士加入勞動人口的傾 向。
- 5.2 非從事經濟活動人口包括所有在統計 前七天內並無職位亦無工作的人士,在這七天 內正在休假的人士及失業人士除外。料理家務 者、退休人士及十五歲以下的人士(例如學生) 等均包括在內。
- 5.3 *就業人口*包括所有在統計前七天內有做工賺取薪酬或利潤或有一份正式工作的十五歲及以上的人士。
- 5.4 *就業不足人口*包括在統計前七天內在 非自願情況下工作少於三十五小時,而在統計 前三十天內有找尋更多工作,或即使不是找尋 工作,但在統計前七天內可擔任更多工作的就 業人士。根據此定義,因工作量不足而在統計 前七天內放取無薪假期的就業人士,若在該七 天期間內工作少於三十五小時甚或全段期間 都在休假,亦會被界定爲就業不足人士。就業 不足人口爲就業人口的一部分。
- 5.5 *失業人口*由所有失業人士構成。一名十五歲或以上人士符合下列情況,便被界定爲失業人士:
- (i) 在統計前七天內並無職位,且並無爲賺 取薪酬或利潤而工作;
- (ii) 在統計前七天內隨時可工作; 及
- (iii) 在統計前三十天內有找尋工作。

5. Concepts and Methods

- 5.1 The *economically active population*, synonymous with the *labour force*, comprises the employed population and the unemployed population. The labour force participation rate refers to the proportion of labour force in the population aged 15 and over. This is a measure of the propensity of persons of working age to be in the labour force.
- 5.2 The *economically inactive population* is made up of those persons who have not had a job and have not been at work during the seven days before enumeration, excluding persons who have been on leave/holiday during the seven-day period and persons who are unemployed. Persons such as home-makers, retired persons and those below the age of 15 (e.g. students) are thus included.
- 5.3 The *employed population* consists of those persons aged 15 and over who have been at work for pay or profit during the seven days before enumeration or have had formal job attachment.
- 5.4 The *underemployed population* comprises those employed persons who have involuntarily worked less than 35 hours during the seven days before enumeration and have sought additional work during the thirty days before enumeration, or have not sought but have been available for additional work during the seven days before enumeration. Following this definition, employed persons taking no-pay leave due to slack work during the seven days before enumeration are also classified as underemployed if they worked less than 35 hours or were on leave even for the whole period during the seven-day period. The underemployed population is a part of the employed population.
- 5.5 The *unemployed population* comprises all unemployed persons. For a person aged 15 or over to be classified as unemployed, that person should:
- (i) not have had a job and should not have performed any work for pay or profit during the seven days before enumeration;
- (ii) have been available for work during the seven days before enumeration; *and*
- (iii) have sought work during the thirty days before enumeration.

- 不過,一名十五歲或以上的人士,如果他符合上述(i)和(ii)的條件,但沒有在統計前三十天內找尋工作的原因爲相信沒有工作可做,則仍會被界定爲失業,即所謂「因灰心而不求職的人士」。
- 5.6 *失業率*是指失業人士在勞動人口中所佔的比例。計算方法是將失業人數除以勞動人口數目,再乘以 100%。
- 5.7 有關各行業或各職業的失業率反映從事個別行業或職業的人士失業的嚴重程度。但是,在計算有關按行業或職業劃分的失業率時,要注意兩點:(i)失業人士是按其以前從事的行業或職業劃分,該行業或職業跟他們日後將從事工作的行業或職業未必相同;及(ii)沒有首次求職人士和重新加入勞動人口的失業人士以前從事行業或職業的資料。因此,按行業或職業劃分的失業率不能與整體失業率作嚴謹比較,同時亦須謹慎闡釋。
- 5.8 「綜合住戶統計調查」採用了結構完善的問卷以搜集所需的數據,從而客觀和準確地界定被訪者的經濟活動身分。
- 5.9 有一點要留意,在「綜合住戶統計調查」中,並沒有使用如「家庭主婦」和「退休人士」之類的通稱。進行統計調查時,所用的問卷採用了一連串嚴謹而客觀的問題,以搜集所需的數據,從而界定一名受訪人士是否失業人士。一名人士若全時間在家中料理家務,則不包括在勞動人口中(即「非從事經濟活動」),亦不會被界定爲「就業」或「失業」。另一方面,若一名已婚的女士,身分雖然屬於一般所稱的「家庭主婦」,但隨時可工作及正積極地找尋工作,按照定義,她會被界定爲「失業人士」。

- However, if a person aged 15 or over fulfils the conditions (i) and (ii) above but has not sought work during the thirty days before enumeration because he believes that work is not available, he/she is still classified as unemployed, being regarded as a so-called "discouraged worker".
- 5.6 Unemployment rate refers to the proportion of unemployed persons in the labour force. It is computed by dividing the number of unemployed persons by the size of the labour force and multiplying the quotient by 100%.
- 5.7 The unemployment rates by industry or occupation reflect the degree of severity of unemployment in respect of persons engaged in individual industries or occupations. However, two points have to be noted in deriving the unemployment rates by industry or occupation: (i) unemployed persons are classified according to their previous industry or occupation which may not necessarily be the one which they will enter subsequently; and (ii) there is no information on previous industry or occupation in respect of first-time job-seekers and re-entrants into the labour force who are unemployed. Such rates are therefore not strictly comparable to the overall unemployment rate and should be interpreted with caution.
- 5.8 A well-structured questionnaire is adopted in the GHS to collect the required data for classifying the economic activity status of the respondents objectively and accurately.
- It should be noted that generic terms like "housewife" and "retired person" are not used in the GHS. In conducting the survey, the questionnaire adopted contains a series of rigorous and objective questions in order to collect the required data for classifying whether a person being enquired is unemployed or not. If a person is engaged in household work on a full time basis at home, this person is outside the labour force (i.e. being "economically inactive") and he will not be classified as "employed" or "unemployed". On the other hand, if a married female regards herself as the so-called "housewife" but is available for work and is actively seeking work, she is classified "unemployed" in accordance with the definition.

- 5.10 在非從事經濟活動人士中,有些人士若「遇上」對其有利的工作條件時(例如酬金符合他們的期望、工作時間有足夠彈性或工作地點接近居所),才會考慮投入勞動人口。但是,他們個別的意願未必符合本地勞工市場的一般情況。根據國際標準,雖然他們有工作意欲,但仍應界定爲非從事經濟活動人士。然而,這些人士雖不屬失業人口的一部分,但是有關這些人士的統計數字仍是有用的統計資料。以香港而言,政府統計處可提供一些關於這方面的統計數字。(備註:讀者可參考政府統計處出版的第三十一號、第四十一號及第五十一號有關「非從事經濟活動人士若遇上合適工作時會接受工作的意願」的《專題報告書》。)
- 5.11 有一點亦要留意,「失業」 所指的是一種狀態,而並非「失去工作」的事件(例如遭解僱或遣散,或因其他理由而離職)。故此,一些被解僱或因其他理由離職的人士,若在很短期間內已轉爲從事另一份工作,雖然他們在有關期間內曾經歷「失去工作」的事件,但根據定義,他們在統計時並不算在失業人口內。
- 5.12 由於失業率受季節性變異(包括首次求職人士所導致的季節性差異、假期影響及業務的季節性起伏)的影響,故政府統計處公布失業率時已作出季節性調整。經季節性調整的失業率,更能確切反映失業的趨勢,以便比較不同時間的失業率。在本文中,載列於第三節的整體失業率已經季節性調整,而載列於第四節的按選定特徵分析的失業率,由於數據的局限,則沒有經季節性調整。
- 5.13 有關「綜合住戶統計調查」所涉及的資料項目及其相關的概念和定義的詳細資料,刊載於《綜合住戶統計調查按季統計報告書》內。

- 5.10 There are also cases that among the economically inactive persons, some might consider entering the labour force only if they "encounter" jobs with terms favourable to their own situations (e.g. remuneration meeting their own expectation, working hours with adequate flexibility or workplace near home). However, their specific wishes may not be commensurate with prevailing local conditions in According to international the labour market. standard, such persons should still be classified as economically inactive, despite the fact that they have some desire for work. Although such persons do not form part of the unemployed population, statistics on them are useful information in their own right. In the case of Hong Kong, some relevant statistics are available in the Census and Statistics Department (C&SD). (Note: Reference could be made to the Special Topics Reports No. 31, No. 41 and No. 51 on the topic "Desire of economically inactive persons for taking up jobs if being offered suitable employment" published by the C&SD.)
- 5.11 It should also be noted that "unemployment" refers to a state of affairs, but not the events of "losing a job" like dismissal or lay-off or having left a job for other reasons. Thus, for persons who have been dismissed from their jobs or who have left their jobs for certain reasons, but have managed to take up another job within a short period of time, they should not be counted in the unemployed population by definition at the time of enumeration, even though they have experienced the event of "losing a job" during the period concerned.
- 5.12 As unemployment rate is subject to seasonal variations (such as seasonal variations in the number of first-time job-seekers, holiday effects and seasonal ups and downs in business activities), seasonal adjustment has been made when the unemployment rate is released. The seasonally adjusted unemployment rate so compiled can better reflect the underlying trend of unemployment and facilitate the comparison of unemployment rates over time. In this article, seasonal adjustment has been applied to the overall unemployment rates presented in Section 3, while those unemployment rates analysed by selected characteristics as presented in Section 4 are not seasonally adjusted because of data limitation.
- 5.13 Details about the data items included in the GHS and their corresponding concepts and definitions are given in the *Quarterly Report on General Household Survey*.
