# 香港經濟的四個主要行業及其他選定行業 The Four Key Industries and Other Selected Industries in the Hong Kong Economy

香港政府一直積極推動經濟發展,以保持香港的競爭優勢。香港的四個傳統主要行業,包括金融服務、旅遊、貿易及物流和專業及工商業支援服務,可帶動其他行業的發展,創造就業,是香港經濟動力的所在。此外,文化及創意產業、醫療產業、教育產業、創新科技產業、檢測及認證產業,以及環保產業等選定新興行業,亦被確認為享有優勢,可作進一步發展。

有關四個主要行業以及選定新興行業在 2012 年的經濟貢獻及就業人數,政府統計處已在 2014 年 4 月出版的《香港統計月刊》的專題文章中加以分析。本文加入了 2013 年的統計數字,是 2014 年出版的專題文章的更新版。

The Government has been actively pursuing economic development in order to keep up the competitive advantage of Hong Kong. The traditional Four Key Industries in Hong Kong, including financial services, tourism, trading and logistics, and professional and producer services, have been the driving force of Hong Kong's economic growth, providing impetus to growth of other sectors and creating employment. Besides, selected emerging industries, including cultural and creative industries, medical services, education services, innovation and technology, testing and certification services, and environmental industries, have also been identified as enjoying advantages for further development.

#### 香港經濟的四個主要行業及其他選定行業

### The Four Key Industries and Other Selected Industries in the Hong Kong Economy

#### 1. 引言

- 1.1 香港政府一直積極推動經濟發展,以保持香港的競爭優勢。香港的四個傳統主要行業,包括金融服務、旅遊、貿易及物流和專業及工商業支援服務,可帶動其他行業的發展,創造就業,是香港經濟動力的所在。此外,文化及創意產業、醫療產業、教育產業、創新科技產業、檢測及認證產業,以及環保產業等選定新興行業,亦被確認為享有優勢,可作進一步發展。
- 1.2 根據「香港標準行業分類 2.0 版」<sup>1</sup> 的 界定,四個主要行業及選定新興行業中,有些 會橫跨不同的行業。有見及此,政府統計處致 力強化其數據搜集系統,並已發展相關的統計 架構以量度這些行業的增加價值 <sup>2</sup> 及就業人數。
- 1.3 有關四個主要行業以及選定新興行業在 2012 年的經濟貢獻及就業人數,政府統計處已在 2014 年 4 月出版的《香港統計月刊》的專題文章中加以分析。本文加入了 2013 年的統計數字,是 2014 年出版的專題文章的更新版。有關各行業的涵蓋範圍的詳情,請參閱政府統計處的網站 (www.censtatd.gov.hk/hkstat/sub/sc80\_tc.jsp)內所載的資料。

#### 1. Introduction

- The Government has been actively pursuing 1.1 economic development in order to keep up the competitive advantage of Hong Kong. traditional Four Key Industries in Hong Kong, including financial services, tourism, trading and logistics, and professional and producer services, have been the driving force of Hong Kong's economic growth, providing impetus to growth of other sectors and creating employment. Besides, selected emerging industries, including cultural and creative industries, medical services, education services, innovation and technology, testing and certification services, and environmental industries, have also been identified as enjoying advantages for further development.
- 1.2 Noting that some of the Four Key Industries and selected emerging industries straddle across different industries defined by the Hong Kong Standard Industrial Classification (HSIC) Version 2.0 <sup>1</sup>, the Census and Statistics Department (C&SD) has endeavoured to make suitable enhancements to the data collection system and develop the relevant statistical framework for measuring the value added <sup>2</sup> and employment in respect of these industries.
- 1.3 A feature article analysing the economic contribution and employment situation in respect of the Four Key Industries and selected emerging industries in 2012 was published in the April 2014 issue of the *Hong Kong Monthly Digest of Statistics*. This article is an updated version of the article published in 2014, with figures for 2013 incorporated. For details of the coverage of the respective industries, please refer to the information contained in the website of C&SD (www.censtatd.gov.hk/hkstat/sub/sc80.jsp).
- 1 HSIC is a statistical classification scheme for compilation and dissemination of sectoral economic statistics. The HSIC Version 2.0 is the latest version of HSIC modelled on the United Nations' International Standard Industrial Classification of All Economic Activities Revision 4 with local adaptations.
- Value added is a term used in national accounting. In brief, value added measures the net output of an economic activity, i.e. the value of goods and services produced *less* the value of goods and services (e.g. purchase of materials and supplies, rental, business services charge) used in production. Sum of value added of all economic activities in an economy equals to its Gross Domestic Product.

<sup>2</sup> 增加價值是一個國民經濟核算的名詞。簡單來說,增加價值量度一個經濟活動的淨產值,即所生產的貨物和服務的價值減去生產過程中消耗的貨品和服務(例如購買日常經營所需用品、租金、商用服務費)的價值。一個經濟體中所有經濟活動的增加價值的總和等如這個經濟體的本地生產總值。


#### 2. 四個主要行業

- 2.1 整體計算,四個主要行業在 2013 年為香港經濟帶來 12,125 億元的增加價值,並僱用 1764 200 人。與 2012 年比較,2013 年四個主要行業的增加價值及就業人數分別增長 3.9% 及 2.1%。 (圖 1、表 1 及表 2)
- 2.2 就近年四個主要行業對整個經濟體的貢獻而言,四個主要行業的總增加價值在 2013年佔本地生產總值的 57.8%,與 2008年的57.7%相若。在 2013年,旅遊業和專業服務及其他工商業支援服務業佔本地生產總值的百分比較 2008年為高,但金融服務業和貿易及物流服務業佔本地生產總值的百分比相比2008年為低,並抵銷了前兩個行業的百分比增加。另一方面,四個主要行業的就業人數在2013年佔總就業人數的47.3%,較2008年的47.8%稅低。 (表1及表2)

#### 2. Four Key Industries

- 2.1 Taken together, the Four Key Industries in the Hong Kong economy generated value added of \$1,212.5 billion and employed 1 764 200 persons in 2013. The value added and employment in respect of the Four Key Industries increased by 3.9% and 2.1% respectively in 2013 compared with 2012. (Chart 1, Table 1 and Table 2)
- 2.2 As regards the contribution of the Four Key Industries to the total economy in recent years, the share of the total value added of these industries in Gross Domestic Product (GDP) was 57.8% in 2013, similar to that of 57.7% in 2008. The percentage shares of tourism and professional services and other producer services industries in GDP in 2013 were higher than those in 2008, offset by the decline in percentage shares of financial services and trading and logistics services industries in GDP over the same period. On the other hand, the contribution of the Four Key Industries to total employment in 2013 was 47.3%, slightly lower than that of 47.8% in 2008. (Table 1 and Table 2)

- To avoid overlapping of economic activities in the Four Key Industries, it is necessary to compile statistics of "other producer services". "Other producer services" refer to producer services other than financial services, tourism, trading and logistics, and professional services.
- (2) Refers to nominal GDP at basic prices. The contribution of the Four Key Industries is compiled as a percentage share in nominal GDP valued at basic prices. Such GDP figure is slightly different from the commonly used one, i.e. valued at current market prices, in which taxes on products are included.

- 2.3 香港是一個國際金融中心,為市場用家提供多元化的金融產品及服務。2013年金融服務業的增加價值合共3,460億元(佔本地生產總值的16.5%),較2012年的3,193億元增長8.3%。就業人數在2013年為231700人(佔總就業人數的6.2%),較2012年的228800人增長1.3%。2013年金融服務業的顯著增長是由於銀行及股票交投活動暢旺所致。
- 2.4 旅遊業(包括入境<sup>3</sup>及外訪旅遊)在 2013 年帶來 1,059 億元的增加價值,佔本地 生產總值的 5.0%,及僱用 269 700 人,佔總 就業人數的 7.2%。2013 年旅遊業的增加價值 及就業人數相對 2012 年的數字分別增加 11.9% 及 7.5%。入境旅遊佔旅遊業增加價值 的主要部分。2013 年入境旅遊的增加價值為 890 億元,與 2008 年比較,平均每年上升 19.1%。受惠於個人遊計劃的推行及逐步擴大,入境旅遊的增加價值在近年大幅增加,中國內地訪港旅客成為最主要的上升推動力。
- 2.5 以增加價值及就業人數計算,貿易及物流服務業在四個主要行業當中均是最大的行業。該行業在 2013 年為香港帶來 5,005 億元的增加價值(佔本地生產總值的 23.9%),較2012 年 4,954 億元的增加價值上升 1.0%。2013 年貿易及物流服務業增長溫和是由於外圍環境表現頗為疲弱所致。就業人數方面,貿易及物流服務業在 2013 年僱用 767 200 人(佔總就業人數的 20.6%)。

- 2.3 As an international financial centre, Hong Kong provides a wide range of financial products and services to market users. In 2013, the value added of financial services industry amounted to \$346.0 billion, or 16.5% of GDP, with a growth of 8.3% from \$319.3 billion in 2012. The employment in 2013 was 231 700 persons, or 6.2% of total employment, with a growth of 1.3% from 228 800 persons in 2012. The notable growth in 2013 was mainly attributable to the vibrant banking and stock trading activities.
- 2.4 Tourism industry (including both inbound<sup>3</sup> and outbound tourism) generated value added of \$105.9 billion (or 5.0% of GDP) and employed 269 700 persons (or 7.2% of total employment) in 2013. Compared with the figures in 2012, the value added and employment increased by 11.9% and 7.5% respectively in 2013. Inbound tourism accounted for the majority share of the value added of tourism. Its value added was \$89.0 billion in 2013, representing an average annual growth rate of 19.1% when compared with 2008. The value added of inbound tourism increased significantly in recent The main impetus of growth came from visitors from the mainland of China, benefited from the launch and progressive extension of the Individual Visit Scheme.
- 2.5 The trading and logistics services industry is the largest among the Four Key Industries, in terms of both value added and employment. It generated value added of \$500.5 billion in 2013 (or 23.9% of GDP), with 1.0% growth from \$495.4 billion in 2012. The growth of the trading and logistic services industry was moderate as the external environment was rather sluggish in 2013. In terms of employment, the trading and logistics services industry employed 767 200 persons in 2013 (or 20.6% of total employment).
- 3 人境旅遊包括零售業、住宿服務(包括酒店、賓館、旅舍及其他提供短期住宿服務的機構單位)、餐飲服務、運輸及個人服務等,但只限於向旅客提供服務的部分。根據國際慣用方法,在量度入境旅遊的貢獻時,會根據來自旅客的收益佔與旅遊有關的經濟活動的總業務收益的百分比計算旅遊比率,再利用這些比率把有關經濟活動內由入境旅遊所衍生的增加價值和就業人數區分。
- Inbound tourism covers retail trade, accommodation services (covering hotels, guesthouses, boarding houses and other establishments providing short term accommodation), food and beverage services, transport and personal services etc., yet pertaining only to the part provided to visitors. According to international practices, to measure the contribution of inbound tourism, tourism ratios for tourism-related economic activities are estimated by shares of business receipts from visitors in total business receipts, and are used to allocate value added and employment in respect of these activities to inbound tourism.

2.6 作為一個全球商業樞紐,香港的專業服務及其他工商業支援服務業在 2013 年合共為本港帶來 2,602 億元的增加價值(佔本地生產總值的 12.4%),並為 495 600 人(佔總就業人數的 13.3%)提供職位。與 2012 年比較,專業服務及其他工商業支援服務業的增加價值上升 1.0%,就業人數則上升 2.6%。專業服務業在 2013 年錄得穩健增長,並為整個行業的增長帶來支持。

2.6 Being an important global business hub, professional services and other producer services industry in Hong Kong together generated value added of \$260.2 billion (or 12.4% of GDP) and provided jobs for 495 600 persons (or 13.3% of total employment) in 2013. The value added and employment increased by 1.0% and 2.6% respectively when compared with 2012. The solid growth in professional services in 2013 rendered support to the growth of the whole industry.


#### 3. 其他選定行業

3.1 選定新興行業在 2013 年為香港經濟帶來 1,906 億元的增加價值,較 2012 年的 1,759 億元顯著上升 8.3%。這些行業的增加價值佔本地生產總值的百分比由 2012 年的 8.7% 增加至 2013 年的 9.1%。 (圖 2 及表 3)

#### 3. Other selected industries

3.1 Selected emerging industries in the Hong Kong economy generated value added of \$190.6 billion in 2013, increased notably by 8.3% from \$175.9 billion in 2012. The value added of these industries expressed as a percentage of GDP rose from 8.7% in 2012 to 9.1% in 2013. (Chart 2 and Table 3)

- 3.2 就業人數方面,這些選定行業在 2013 年共僱用 450 250 人,較 2012 年的 434 980 人上升 3.5%。這些行業對總就業人數的貢獻 由 2012 年的 11.9%增加至 2013 年的 12.1%。 (圖 2 及表 4)
- 3.3 文化及創意產業已被國際認定在經濟及 社會領域中扮演日趨重要的角色。該產業在 2013 年為香港帶來 1,061 億元的增加價值 (佔本地生產總值的 5.1%),較 2012 年的 978 億元上升 8.4%。當中升幅較顯著的組成 界別 <sup>4</sup> 包括軟件、電腦遊戲及互動媒體,藝術 品、古董及工藝品,以及廣告。另一方面, 2013 年的就業人數為 207 490 人(佔總就業 人數的 5.6%),相比 2012 年的 200 370 人上 升 3.6%。
- 3.4 醫療產業在 2013 年的增加價值為 324 億元(佔本地生產總值的 1.5%),與 2012 年的數字比較上升 10.1%。增長主要是 因為社會對私家診所所提供的醫療服務的需求增加。就業人數方面,醫療產業在 2013 年的就業人數為 82 100 人(佔總就業人數的 2.2%),相比 2012 年的 78 960 人增加 4.0%。
- 3.5 教育產業在 2013 年的增加價值為 242 億元(佔本地生產總值的 1.2%),較 2012 年的 226 億元上升 7.1%。增長主要是由於社會對自資大學及專上教育服務,以及幼稚園、私營小學及中學(牟利及非牟利)的需求上升所致。就業人數方面,教育產業在 2013 年的就業人數為 74 920 人(佔總就業人數的 2.0%),相比 2012 年的 73 110 人增加 2.5%。

- 3.2 As for employment, these selected industries together employed 450 250 persons in 2013, increased by 3.5% from 434 980 persons in 2012. The contribution of these industries to total employment rose from 11.9% in 2012 to 12.1% in 2013. (Chart 2 and Table 4)
- Cultural and creative industries have been recognised by the international community for their increasingly important role in both economic and They generated value added of social realm. \$106.1 billion in 2013 (or 5.1% of GDP), registering 8.4% growth from \$97.8 billion in 2012. significant increases were seen in the component domains <sup>4</sup> of software, computer games interactive media; art, antiques and crafts; and advertising. On the other hand, employment stood at 207 490 persons in 2013 (or 5.6% of total by employment), increased 3.6% from 200 370 persons in 2012.
- 3.4 The value added of medical services industry was \$32.4 billion in 2013 (or 1.5% of GDP) and increased by 10.1% compared with the figure in 2012. The increase was mainly attributable to the growing demand for medical services provided by private clinics. As for employment, the medical services industry employed 82 100 persons in 2013 (or 2.2% of total employment), representing a growth of 4.0% from 78 960 persons employed in 2012.
- 3.5 The value added of education services industry was \$24.2 billion in 2013 (or 1.2% of GDP), with a growth of 7.1% from \$22.6 billion in 2012. The increase was mainly due to the increasing demand for self-financing university and post-secondary education services; and kindergarten, private primary and secondary schools (both profit and non-profit-making). In terms of employment, the education services industry employed 74 920 persons in 2013 (or 2.0% of total employment), with an increase of 2.5% from 73 110 persons employed in 2012.

For measuring the economic contribution of cultural and creative industries, the component domains of cultural and creative industries are mapped with HSIC Version 2.0 by C&SD for delineating the specific economic activities covered in each component domain. Thus, each domain comprises economic activities which may straddle across different industries under the HSIC classification scheme.

- 3.6 創新科技是推動經濟增長及發展的主要動力。這些經濟活動能幫助有關機構發展及推出技術嶄新或顯著優化的產品或程序作商業用途。創新科技產業在 2013 年的增加價值為 147 億元(佔本地生產總值的 0.7%),而在 2012 年則為 134 億元,按年上升 9.8%。增長主要是因為工商業機構增加產品及程序創新活動的開支,以及高等教育機構加強研究及發展活動。就業人數方面,在 2013 年,創新科技產業僱用 32 000 人(以相當於全日制的人數計算,數字反映投入創新科技活動的人力資源),佔總就業人數的 0.9%,較 2012 年的 30 240 人增加 5.8%。
- 3.7 檢測及認證產業在香港社會的日常生活 及對外貿易方面均擔當重要角色,例如支援 診斷病症的醫務化驗服務,以及為香港和珠 江三角洲地區所製造的消費品提供測試及檢 驗服務。該產業亦為管理體系提供認證服 務。檢測及認證產業在 2013 年的增加價值為 60 億元(佔本地生產總值的 0.3%),與 2012 年的 58 億元比較按年上升 3.2%。另一 方面,2013 年的就業人數為 13 090 人(佔總 就業人數的 0.4%),相比 2012 年的 12 780 人增加 2.4%。
- 3.8 環保產業獲廣泛認定為一個嶄新的增長 行業,於創造就業及經濟體持續發展的過程 中扮演一個重要的角色。環保產業在 2013 年 的增加價值為 71 億元(佔本地生產總值的 0.3%),較 2012 年的 68 億元增長 5.2%。就 業人數方面,該產業在 2013 年僱用 40 650 人(佔總就業人數的 1.1%),較 2012 年的 39 520 人增加 2.9%。

- Innovation and technology are the key impetus to economic growth and development. They drive the development and introduction of technologically new or significantly improved products or processes in relevant organisations for commercial purposes. The value added of the innovation and technology industry was \$14.7 billion in 2013 (or 0.7% of GDP) and \$13.4 billion in 2012, representing a year-on-year growth of 9.8%. The growth was mainly attributable to increased spending of the business sector on product and process innovation as well as stepping up of research and development activities in the higher education sector. As for employment, the industry employed (in full-time equivalent terms, reflecting the manpower resources deployed to innovation and technology activities) 32 000 persons in 2013 (or 0.9% of total employment), with a growth of 5.8% compared with 30 240 persons in 2012.
- 3.7 Testing and certification services industry plays an important role in daily life of the Hong Kong community as well as in our external trade, e.g. medical testing support in the diagnosis of illnesses, and testing and inspection services for consumer products manufactured in Hong Kong and the Pearl River Delta Region. It also provides certification services for management systems. The value added of the industry was \$6.0 billion in 2013 (or 0.3% of GDP), with a year-on-year growth of 3.2% from \$5.8 billion in 2012. On the other hand, employment stood at 13 090 persons in 2013 (or 0.4% of total employment), increased by 2.4% from 12 780 persons in 2012.
- 3.8 Environmental industries are widely recognised as a new growth sector, generating employment as well as playing a major role in the transition of economies towards sustainable development. The value added of environmental industries was \$7.1 billion in 2013 (or 0.3% of GDP), representing a growth of 5.2% from \$6.8 billion in In terms of employment, the industries 2012. employed 40 650 persons in 2013 (or 1.1% of total employment), with an increase of 2.9% when compared with 39 520 persons in 2012.

#### 4. 其他備註

- 4.1 以上分別提供四個主要行業及其他選定 行業的業務表現的統計分析,數據使用者須 注意這些行業之間的數字可能會出現某程度 的重疊。
- 4.2 此外,有關四個主要行業及其他選定行業對經濟及就業貢獻的估計數字,是反映與其經濟活動有直接關係的增加價值及就業人數,即該等行業在統計期內因從事本身的商業活動而產出的增加價值及僱用的人數。就該等行業而言,每一行業的直接經濟效應以外的貢獻,例如其他行業為該行業的生產活動而提供所需投入的溢出效應,並不計算在內。

#### 4. Other remarks

- 4.1 The above sections provide separate statistical analyses of the business performance of the Four Key Industries and other selected industries. Data users should note that there may be some degree of overlapping among the figures pertaining to these industries.
- 4.2 Besides, it should also be noted that the estimates on the economic and employment contributions in respect of the Four Key Industries and other selected industries reflect the value added and employment directly related to their economic activities, i.e. the value added generated and persons employed by these industries for performing their own business activities during the reference period. For each of these industries, its contributions other than the direct economic impact, such as the spillover impact to other industries which provide inputs for use by the industry concerned for its production activities, are not taken into account.
